Hi Katherine,

A quick update on the ethics legislation I told you about two days ago. The Senate took up the long, complicated “omnibus” bill yesterday afternoon, and after a contentious and confusing debate, the bill was killed. I admit – that surprised me. But given what was in that legislation – a largely meaningless income disclosure requirement, for example, and a new provision that would have made the current system of self-policing *worse* – it was good news.

We’ll keep you in the loop as other ethics-related bills come up.

Now, the other big issue this year is road funding. Many lawmakers, as you know, seem to think the only way to solve a problem is to dump money into it – and to do that they have to raise taxes.

That’s certainly been the case so far this year, with even many “conservative” lawmakers signing on to a hike in the gasoline tax. Accordingly, Gov. Haley’s tax-hike plan was introduced in the House yesterday – our [brief analysis](#) of the bill was posted this afternoon. Another plan getting lots of attention – this one sponsored by Rep. Gary Simrill and similarly including tax hikes – was also introduced yesterday (our analysis [here](#)).

If you only take away one thing from this whole debate, though, it should be this: that most of the analysis being pushed by politicians *simply isn’t based in reality*. You might have heard about DOT’s \$1.5 billion yearly shortfall ... Well the company that came up with *that*

number has [received almost \\$13 million from state taxpayers](#) and is likely to receive more. Hardly an objective source!
