Associated Press: Gay marriage not immediately likely in SC

The U.S. Supreme Court on Monday denied appeals from five states seeking to preserve gay-marriage bans. The move doesn't mean same-sex marriages will begin immediately in South Carolina, but experts say such unions probably aren't too far off.

Note: Gov. Nikki Haley said she backs Wilson's decision to keep fighting. "Our voter-approved state law should be followed until a court rules on it directly," said Doug Mayer, Haley's spokesman.

Note: "Gov. Haley, like the majority of South Carolinians, supports traditional marriage as defined between one man and one woman, and in accordance with state law, will continue to uphold those values," Mayer said last year.

In August 2013, Tracie Goodwin and Katie Bradacs filed a case against South Carolina, naming Governor Nikki Haley and Attorney General Alan Wilson as defendants. The couple married in Washington, D.C., in 2012, and are seeking to have their marriage recognized by the state.

Note: The case, commonly referred to as Bradacs v. Haley, was put on hold earlier this year while an earlier case from Virginia, Bostic v. Schaefer, worked its way through the court system.

The Supreme Court unexpectedly cleared the way Monday for a dramatic expansion of gay marriage in the United States and may have signaled that it's only a matter of time before same-sex couples can marry in all 50 states.

Note: But South Carolina Attorney General Alan Wilson said he would continue to fight to uphold his state constitution's ban on gay marriage.

The Supreme Court refused to get involved in the national debate over same-sex marriage Monday, leaving intact lower court rulings that will legalize the practice in 11 additional states.

Note: It also will bring along six other states located in the judicial circuits overseen by those appellate courts: North Carolina, South Carolina, West Virginia, Colorado, Kansas and Wyoming. Lower court judges in those states must abide by their appeals court rulings.

State bans on same-sex marriages have been falling around the country since summer 2013, when the Supreme Court ordered the federal government to recognize state-sanctioned gay marriages. The high court Monday cleared the way for more expansion by turning away appeals from five states seeking to prohibit it.

Note: The Supreme Court refused to hear appeals from Indiana, Oklahoma, Utah, Virginia, and Wisconsin in a ruling also affecting six states where same-sex marriages had been put on hold pending high-court review: Colorado, Kansas, North Carolina, South Carolina, West Virginia and Wyoming.

CBS: South Carolina can keep redrawn districts, Supreme Court says

The Supreme Court said Monday that South Carolina can keep its redrawn state house and congressional maps despite a challenge from black voters in the state. The justices offered no comment when they rejected the appeal from voters, who wanted the court to re-examine the newly drawn borders of state house and congressional districts.

Note: In 2012, six black voters from counties in the southern and eastern parts of the state sued Republican Gov. Nikki Haley and the Republican-controlled state legislature.
