Dear Mr. Waldrep:

The Bureau of Labor Statistics will not announce the precise amount of the January 2012 cost-of-living adjustment (COLA), if any, until the third week of October 2011. For State planning purposes, an estimated spread of 3.4% - 3.9% for the COLA can be used. The COLA is based on the increase to the consumer price index base period, which ends September 30, and is established by law.

We need to know whether you want to change your supplement rates or keep the same rates as in 2011. If the State is changing any rates, we must receive written confirmation showing the amount of the January 2012 State payment level for each living arrangement variation. As usual, we face restrictive implementation deadlines to reprogram the COLA changes. Therefore, we would appreciate your immediate attention to this matter.

If we do not receive notification of a rate change, we will assume that the rates are not changing. If a State decision cannot be obtained because of the need for State legislation or other reasons, please let us know when a decision is expected.

Please provide us with written confirmation of your decision by October 21, 2011. Also, it would be helpful if you would FAX your response before mailing it.
