### Governor Nikki Haley News:

**The State:** SC approves \$123 million in Volvo incentives

South Carolina agreed Tuesday to borrow up to \$123 million for incentives that the state used to help lure Volvo to build its first North American auto plant in Berkeley County. The state Budget and Control Board unanimously approved issuing bonds to pay for site and road work associated with the \$500 million, 2,000-employee plant off Interstate 26, scheduled to open in 2018.

**Note:** “If we had not done it this way, they would have been in Georgia,” Haley said, referring to the other state that was a finalist for the auto plant. “We did what the company asked.”

A state financial board has given South Carolina State University a five-year reprieve from repaying a \$6 million loan. The Budget and Control Board voted unanimously Tuesday to let the financially troubled school pay the money back by 2020. South Carolina's only public historically black university was supposed to pay it back by June 30 but can't. The school's debt exceeds \$20 million.

Two weeks after being lectured by lawmakers, Gov. Nikki Haley today told the Legislature's top financial officers that had she not agreed to borrow \$123 million for incentives for Volvo, the automaker would have chosen Georgia for its new \$500 million plant.

**Note:** “I did get an earful from you and your colleagues as well as the House members in terms of this is a legislative state and I need to remember that,” Haley told Leatherman. “I am reminded of that every day. However, I will tell you there is a reason Volvo wanted to do it this way.”

South Carolina's senators have advanced a resolution that keeps state government funded past the start of the fiscal year. A committee of Senate and House budget writers failed to reach a compromise on the state's roughly \$7 billion budget last week. To avoid a government shutdown, lawmakers were forced to pass a continuing resolution that ensures all of the state's obligations are met and employees are paid.

**Note:** An amendment added to the resolution also keeps the position of secretary of the Department of Transportation under Gov. Nikki Haley; a provision that was scheduled to sunset at the start of the fiscal year on July 1.

In an effort to gather more details about the case of an off-duty Aiken County Sheriff's Deputy charged with involuntary manslaughter in the shooting death of his wife, the Aiken Standard filed Freedom of Information Act requests Tuesday with the South Carolina State Law Enforcement Division and other investigating agencies.

**Note:** While body-cam video is exempt from the Act under a law passed by the General Assembly earlier this month and signed into law by S.C. Governor Nikki Haley, the newspaper also is requesting the release of body-cam footage for the North Augusta officers.

The College of Charleston Board of Trustees has approved a tuition increase of just over 3 percent for the coming academic year. Area media outlets report the board approved the increase Monday.
