Okay gentleman, Here is the legal answer that will send all of you to federal prison likely for life if this matter proceeds any further. To begin with, I hold the White House I. To begin with your own South Carolina Constitution under Article I Declaration of Rights Section 4 states the following: "No...law impairing the obligation of contracts ... shall be passed,..." Technically you are totally illegal to exist or function as a state agency of South Carolina under this totally prohibitive clause of the South Carolina Constitution. THIS SAME PROHIBITION EXISTS IN THE U.S. CONSTITUTION SAYING THAT NO STATE MAY CLAIM THIS LEGAL RIGHT TO INTERFERE WITH COMMERCE IN AMERICA.
