







CONSULTANT - PRELIMINARY ENGINEERING SERVICES RICHLAND COUNTY

Pursuant to the Commission's previous action of November 19, 1987 authorizing the Department to seek Consultant Engineering Services for the design of two railroad structures to be located on Trenholm Road Extension and O'Neil Court Extension, the Department has entered into an agreement with Ralph Whitehead and Associates in the amount of \$198,210.00 to provide such services.

These projects will be financed by Federal Aid Urban System (MG) funds.

Recommendations - 07/21/88

I-85 Relocation - Supplemental Agreement #4 - Spartanburg County

The Commission is hereby requested to allow the Department to enter into Supplemental Agreement #4 with the Consulting Engineering firm of Florence and Hutcheson, Inc. for additional work required for the above described project.

The additional work will be for extending the project limits so plan preparation for revisions to the S. C. Route 129 and Road S-57 interchanges with existing Interstate Route 85 can be accomplished. This work is necessary since the six laning of the new interstate will require the replacement of the bridges at these locations. In addition, the supplemental agreement will provide for reworking the previously completed four lane signing and paving plans throughout the limits of the project.

The supplemental agreement is for an estimated additional \$746,464. It is estimated that the Department will require \$28,536 to supervise the supplemental agreement.

JAMES ISLAND EXPRESSWAY FILES 10.158A.3, .4, & .5

SUPPLEMENTAL AGREEMENT FOR CONSTRUCTION MANAGEMENT

At the present time, the Department does not have sufficient staff in the Charleston District to provide construction management services on the James Island Expressway project in Charleston County. It is recommended that the Department enter into a supplemental agreement with the design consultant on this project to provide these services. Negotiations with the consultant are now underway due to the time constraints on mobilizing inspection personnel. The cost for these services is estimated not to exceed \$6,000,000. These funds will be provided as part of the construction contract under the Federal Discretionary Bridge Replacement program.

AGREEMENT WITH NORTH CAROLINA DEPARTMENT OF TRANSPORTATION
TO PROVIDE IMPROVEMENTS ALONG I-77 IN YORK COUNTY

The Department requests Commission approval to enter into an agreement with North Carolina Department of Transportation to provide engineering services for the design and construction of certain improvements on I-77 from the N. C. State Line to S. C. Exit 74 at Carowinds.

This project is approximately 3/4 mile long and will provide for the extension of N. C. Department's Project 8.1670102. The scope of work will provide for designing and construction two additional lanes (one in each direction) along I-77 from the N.C. State Line to S. C. Exit 74 at Carowinds.

Funding for this project will be Interstate 4-R and is anticipated to cost approximately \$1,000,000.

The agreement is anticipated to cost \$115,000 which will be funded by Federal Aid Interstate 4R funds.

During the State's Fiscal Year 1988-89, the Department anticipates receiving UMTA's Notification of Grant Approval for the Federal Funds and the accompanying Grant Agreements of UMTA.

It is requested that the Commission authorize the Department to enter into written agreement(s) with UMTA to carryout the Department's statewide public transportation responsibility, in accordance with the requirements established under the Section 8, Section 16(b)(2), Section 18 and Rural Transit Assistance Programs of the Urban Mass Transportation Act of 1964, as amended.

ALLOCATIONS - 1988-89 BUDGET CORRECTIONS

In preparation for operating budget adjustments, requests from two organizations were inadvertently left out of the final budget presented to the Commission in June and one salary from the Public Transportation Division - Planning section was left out when salary adjustments were calculated as the position had been on maternity leave and no salary was included with salary data supplied by the State Human Resource Mgmt Division.

It is therefore recommended that the Commission approve the allocation of \$22,483 from the 1988-89 Budgetary Reserve appropriation to the following accounts:

TRANSFER OF FUNDS - 1988-89 BUDGET

In June, the Commission approved the operating budget for Engineering Administration in the amount of \$9,997,806 including Equipment Purchases of \$2,410,139. Included in Equipment Purchases is an item for update of the Computer Aided Design and Drafting (CADD) System in the amount of \$1,500,000.

The Engineering Division has found that it is necessary to provide an administrative staff to carry out training, installation and maintenance for the new system.

It is therefore recommended that the Commission authorize the transfer of funds from Engineering Administration-Equipment Purchases to an account under indirect construction for CADD Management in the amount of \$256,950, broken-down below, leaving \$1,243,050 for purchases of additional CADD equipment.
