The Commission instructed the Secretary to request further information before granting a request from the State Planning Board for transfer of 1943-44 appropriations.

The Commission instructed the Secretary to obtain further information before approving payment of a bill of Dr. Josiah E. Smith, of Charleston, S. C., for services rendered to Miss Gladys Thompson.

The Commission approved a compensation plan for employees adopted by the South Carolina Unemployment Compensation Commission on May 13, 1943.

The Commission requested further information from Dr. Moncrief, Superintendent of the South Carolina Sanatorium, before approving use of a contingent appropriation of \$10,000.00 for maintenance of the Sanatorium.

The Commission requested further information upon the request of Mr. E. F. Gettys, Superintendent of the John De La Howe School, before authorizing use of a contingent appropriation of \$2,000.00.

The Commission approved the appointment by Dr. James H. Hope, State Superintendent of Education, of Pat C. Smith as Chief Accountant provided for in the 1943-44 General Appropriation Act and requiring the approval of the Budget Commission.

The Commission deferred action upon the request of the Tax Commission to provide \$4,000.00 from the Civil Contingent Fund as salary for Mr. P. M. Minus, Executive Assistant of the Tax Commission.
