I was born in Bamberg SC SHIRLEY A WASHINGTON.

HE was born in Georgetown, SC Oct. 20, 1975.

HE HAS BEEN WITH US EVERY SINCE THIS ACCIDENT.

My son was in an accident last year On MAY 29, 2015, in his marked patrol car he was crashed into by a un-licenses driver he was critically injured, he forgot his sinuses medicine at his apartment (WEST PARK APARTMENT, 5530 FOUNTAIN GROVE CIRCLE APT# 219, FAYETTEVILLE, NC 28304) ALVERT CHEWALE TABLET over counter non-drowsy med, the only thing he did wrong he should have called in sick, he went into work at Hoke County Sherriff's Office on May 29, 2015.

Our son is a veteran law enforcement Sgt. For 8yrs. serving the people of HOKE, NC. This accident happened in Fayetteville, NC there was no investigation by Fayetteville City police, Cumberland County DA, THEY NOT REQUEST FOR THE SBI or HIGHWAY PATROL. They never contacted him or gave him a citation verbal or written.

They reported that he was cited the news, he nor we was given a citation at the time he was incapacitate, with 2 Hair line fracture to his skull and he had a concussion. He was hit in his head after airbags came out , the computer malfunctioned and hit it was Matted to his head. We never received A citation written or verbal from them they held him in contempt in the prosecution office they never notified us by phone or mail of a court date.

A un licensed driver crashed into his patrol car on the front right side, there's was no State investigation of why someone would not could not see a law enforcement officers MARKED PATROL CAR. A un-Licenses Driver car hit it and the damage to our son has been so sad he was lied on in the media his boss Sheriff Hubert Peterkin told us had surgery when he didn't that day about his condition. They his work place acted like he wasn't at work they lied on him about him, He was at work all of instruments, phone, computer, and GPS on. Fayetteville City Police never investigated or call for an SBI investigation of our son's case has been going on all this time and they treated him as if he was a criminal at best for a traffic violation of \$132.00 fine. They said he made a legal turn to slow illegal moving violation. He has not receive his due process in the law or his civil rights to be able to defend himself on the citation the District Attorney has yet to unsuspend his licenses or even look at all of the medical documentation confirming his unable to appear anywhere from 29 MAY 2015 until 6 Oct 2015 they just suspended his licenses with no notification. SEDWICK WORKERS COMP, KARENGRAFFUIS CLAIM EXAMINER III contacted him talked to him on June 4, 2015, he was heavily medicated on pain meds. She denied his WORKERS COMP. WHY is A LAW ENFORCEMENT OFFICER WITH A CLEAN RECORD OF INTEGRITY, HONOR, SERVE & PROTECT BEING TREATED THIS WAY?

Please ask the ATTORNEY GENERAL to investigate his accident as well the shooting that happened 30 May2014. Our son had to fight for his life, 2 female deputy's life with Sheriff Peterkin Cousin Mr. Sandy McCall; sadly it was a groin area shooting he tried to take Samuel's gun SBI and the sheriff's internal investigation cleared him of any criminal behavior toward Mr. McCall. His NAME IS Samuel L Morant Jr.

He served 5 yrs. active duty U. S. A. Air Force & 1 yr. Reserves.

Please help someone tried to take his life I believe there's still something wrong going on in his case. HE SHOULD BE ABLE TO DO THE JOB HE LOVES AGAIN OF PROTECTING & SERVING until that time he should be able to receive his WORKERS COMP.
