

INTERNAL STAFF UPDATE*

Wednesday, November 18, 2015

Front Desk – Refugees:

Calls about refugees have significantly decreased. Ms. Sheila's calls were down from more than 600 on Monday to approximately 200 yesterday (13 were pro resettlement). Today, she received only about 50 calls.

Correspondence – Refugees:

Hal has received 542 records about refugees, the majority of which are against allowing Syrians in state.

Legislative – Refugees:

Yesterday, we received three additional letters from Senators Bright and Shealy and 13 GOP members of House Judiciary: Delleney, Burns, Gagon, Loftis, Pope, Simrill, Thayer, Bedingfield, Clemmons, Kennedy, D. Moss, Pitts, and G. Smith.

Legislative – Workforce Proviso Committee

The Workforce Committee has conducted 222 electronic and in-depth telephone interview with business and industry leaders across the state, designed to assess workforce development needs in SC.

The most consistent messages coming out of these surveys were:

- Educate and prepare our workforce at a young age for manufacturing and STEM-related fields.
- Educate parents, teachers, and students about how manufacturing and other STEM-related fields have evolved.
- Continuously focus on STEM education and workforce readiness, both present and long-term need.
- Build collaboration among schools, business, and the state.
- More funding for education is critical.

Commerce – Volvo and DMV:

Our office heard from Commerce that Volvo executives new to the Charleston area were having a difficult time with the North Charleston DMV. We reached out to Acting Director Laganelli, and his district manager is working to resolve the issues. Additionally, Beth will reach out to the Swedish embassy to start the process of getting a reciprocal agreement in place with the DMV regarding the issuing of international licenses.

Medical Incidents/Other Issues

- *Horry County, 11/16/15:* At approximately 11:15 am, applicant Barbara Martin fell while exiting the building. Incident occurred at the exit outside of the elderly/handicapped designated certification/issuance area. Horry County EMS was on site and attended to Ms. Martin. She was released to her driver after an examination. Ms. Martin, who is 81 years of age, stated that her hip and elbow were sore, from the fall, but had no other complaints and did not feel it was necessary to go to the emergency room.
- *Berkeley County, 11/16/15:* A child in the tent that is being utilized to serve the elderly and disabled was playing with a parent's key chain that also had a container of pepper spray attached. The child dispersed the pepper spray into the crowd in the tent. People began coughing, so we immediately evacuated the tent and moved everyone to another part of the large tent that was partitioned off. Everyone stated that they were fine and no one needed medical attention.
