States, Enviros Move To Support EPA's New Methane Rules

Eight states, the city of Chicago and several environmental groups on Monday weighed in at the D.C. Circuit in favor of the U.S. Environmental Protection Agency's regulations reducing methane emissions from new and modified oil and gas infrastructure.

A Texas federal judge on Monday held the Texas Medical Board waited too long before asking him to certify a Fifth Circuit appeal of his ruling that Teladoc Inc. can move forward with a challenge of a rule requiring doctors to see patients face to face before providing remote health care.

DOT Clarifies Regs For Abandoned Oil, Gas Pipelines

The U.S. Department of Transportation on Tuesday clarified its regulations, saying that owners and operators of hazardous liquid, carbon dioxide and gas pipelines are fully responsible for the safety of their pipelines at all times, even if they were abandoned and no longer in active use.

Chamber Calls EEOC Pay Info Reporting Excessive, Unlawful

The U.S. Chamber of Commerce on Monday blasted the Equal Employment Opportunity Commission's proposal to require employers to submit compensation data as part of their reports to the agency, saying the requirement is a costly privacy risk that is inconsistent with the Paperwork Reduction Act and Title VII of the Civil Rights Act.

Ill. Gov. Signs Bill Granting Protections To Domestic Workers

Illinois Gov. Bruce Rauner, a Republican, has signed a bill ensuring that nannies, housecleaners, home care workers and other domestic workers receive the state's minimum wage, protections against sexual harassment and other workplace protections, according to the governor's website.

Fattah, Co-Conspirators Ask Court To Toss Guilty Verdicts

Claiming prosecutors relied on insufficient evidence and that jury instructions were flawed, former U.S. Rep. Chaka Fattah and others convicted in a federal corruption trial asked the court on Monday to overturn their guilty verdicts.

More Illinois Courts To Allow Cameras

Six new Illinois circuit courts will begin allowing cameras in their courtrooms starting next month, joining 45 other county courts in Illinois that have already allowed extended media coverage in their courtrooms.

Calif. Senate OKs Bill Keeping Actors' Age Behind The Curtain

The California state Senate on Monday approved a bill to require online entertainment employment service providers, such as IMDb.com's pro casting service, to keep actors' ages private upon request, a bill touted by its author as a blow against age discrimination.

Advocacy Groups Urge Speedy Biz Data Services Regs

A group of advocacy organizations want the Federal Communications Commission to move quickly on proposed new regulations for business data services, according to an ex parte filing Monday that argued action is necessary to promote competition in a space that largely lacks it.

Cable Group Warns FCC Of Set-Top Legal Problems

The National Cable & Telecommunications Association on Tuesday cautioned the Federal Communications Commission that any proposal to unlock competition in the market for set-top boxes — even if termed “apps-based” — that includes unbundling content would raise legal issues, including ones related to copyright protection.

FCC Slams USTelecom Bid To Nix Network Transition Rules

The Federal Communications Commission has fired back at the U.S. Telecom Association’s D.C. Circuit challenge to new rules regulating the transition from copper to voice over internet protocol networks, telling the appeals court that it has the legal authority to prevent service blackouts for consumers.

T-Mobile Challenges Missouri City’s Tower Permit Denial

T-Mobile hit a Missouri city with a federal court lawsuit Monday alleging the company was denied a special permit for a 90-foot telecommunications tower without the level of reasoning required under the law.

Lehman Brothers Bankruptcy Judge Tapped For FDIC Panel

U.S. Bankruptcy Judge Shelley Chapman, who is overseeing Lehman Brothers’ massive Chapter 11 case in New York, has been chosen to serve on a committee that advises the Federal Deposit Insurance Corp. on how to address the potential failure of large financial institutions.

Unintended Consequences Of New DOL Fiduciary Rule

The U.S. Department of Labor’s new “fiduciary rule,” which redefined the term “fiduciaries” in relation to employee benefit plans under the Employee Retirement Income Security Act, may require ERISA fidelity bonding for advisers who provide discretionary investment management services to 401(k) plans, says Max Schatzow of Stark & Stark.

P3 At USPTO: Time To Re-Examine 'Compact Prosecution'

The U.S. Patent and Trademark Office’s Post-Prosecution Pilot program, which took effect last month, is part of the USPTO’s continuing efforts to reduce the number of requests for continued examination. However, the P3 program actually reduces the opportunities available for applicants to advance their applications, and calls into question the USPTO’s entire approach to “compact prosecution,” says Jeffrey Ingerman of Ropes & Gray LLP.

Inside The New SBA Mentor-Protege Past Performance Rules

One of the changes in the Small Business Administration's expansion of its mentor-protégé program is that agencies must consider projects performed by the individual members of a mentor-protégé joint venture offeror when evaluating experience/past performance. While this is clearly an attempt to help mentor-protégé joint ventures, arguably this change does more harm than good, says Adam Lasky of Oles Morrison Rinker & Baker LLP.
