I was also told by the DSS case worker that I could not include dental and it clearly states I can. This why there was not agreement but even the judge did not complete this case appropriately nor did not the DSS attorney which was not my attorney is more like he was on the NCP side. Also it matter that I have full custody 365 days a year I don't know that DSS even had that correct. The NCP only get her supervised for 2 days a month from 10:00 am to 4:00pm.

The judge and the man from DSS wanted it their way. The Court system and the DSS child support as failed my Daughter!!!! This is not about me. This is about getting a dead beat NCP to provide for his daughter!!! And the system gave him actually what he wanted yet again. So until I have another hearing how does the judge and DSS think I am going to pay for the minor child's daycare?

I even asked the court why the medical expenses cannot be include. And I am not getting an answer. It is listed in the calculation. He never pays any of her medical expense. I pay sometime it depends on how much her ADHD medication is sometimes depending on what she is taking at the time is \$100.00 or more a month. I have \$1500. Deductible to meet each year plus copays to pay.

So someone needs to explain why it included in the worksheet. What determines **Extraordinary Medical Expenses?** Because I asked the question yesterday and no one not the judge or the DSS worker could explain what that includes.?????????

Yes I cussed if that Judge had to go through everything me and my daughter have to go through. And that judge did not do his job that he was supposed to do yesterday. But I did not disrupt your court room. I was the last case and I was not in the court when I said what I said. I have freedom of speech. I also requested that I have an attorney and you told me it would not mater. So you refused me the right to have legal representation.

These are the number because I would pay the same premium no matter how many children are the insurance.

What about medical and dental insurance?

If either the **CP** or **NCP** can obtain insurance at a reasonable cost, that cost will be included in the calculation of the child support award. The parent providing the insurance coverage will receive a credit on his/her portion of the child support obligation.

The DSS attorney only had the following calculation (the 1st BOX) filled on his paper work though at mediation prior to this all the numbers were given to the DSS caseworker. Also no adjustment was taken because of another child in the home. So I should have also been given an adjustment for have 2 child in the home. I was sitting there trying to tell the DSS attorney he did have it calculated correctly, and he would not listen!!!! I should not have to take off work because they screwed up the order yesterday. I already mess 4 hours of work yesterday because the scheduled us at 9:00 but then I was told while at the clerk of court we were not being seen until starting at 11:30 then we were not seen until 12:15pm. Is DSS and the court going to pay me for my missed time of work.

David Lawson Child Support order should not have change actually it should have went up by my calculation and he is behind you should be take the maximum of the \$20.00 instead of \$10.00

I was completed disrespect by ever man in the court room including the police officers.

I also had a the child support hearing of which Mark Harrell who did not know our case. Was very unprepared. Dropped my child support from 122.00 a week to 53.00 week this is ridiculous this is not even half of her daycare. I am sorry I have better myself and got a better job. However David is capable of making \$15 to \$16 an hour. It is not Elizabeth's fault because he loses his jobs because he will not go in or he quits. Also the court need to make if do what is necessary through the VA in order for Jade to draw her apportionment, since he want to give the story he was injured of which that is not why he was discharged.

I quested that I have an attorney at that time the Judge refused to allow me to have an attorney Judge Tommy B Edwards. I have every right to be represented by an attorney! And that judge refused. Stated it would not matter. I

would like the contempt charge that he gave to be dismissed or I am going to sue. I was discriminated again because I was a women with three men in the court room.

He allowed David Lawson who is also the compliant in this alleged abuse case to take advantage of the court system!!!!!! Judge Tommy E Edwards in contempt as he denied my right to have an attorney. He actually did not even state that was an option. The DSS attorney was not representing me.

My child care for Elizabeth Lawson is \$135.00 weekly, which is \$540.00 a month. They did not include that in the order. So the court is not even making David pay half of the Daycare expense. They also did not included the fact my income supports two children not just one. Also they would not include the medical expense that I pay. In the child support order not only is the child support considered but also the medical bills and the insurance he is also by the original court keep the minor child on insurance. The Judge's order from today should be thrown out due to he denied me my rights to have an attorney when I requested one. He stated to me it would not matter. He should not be on a bench nor should the DSS attorney be in practice- he did not make the appropriate calculations.

They allowed his child support to be lowered and he is behind \$1500.00.

Nikki Haley has some major issue with DSS as a whole and with child support in Spartanburg County. They had me schedule for 9:00am. The case was not heard until 12:20.

Due to me having to hire an attorney with the false report of abuse DSS has caused me a financial hardship of \$3475.00 plus pain and suffering for my two children and my entire family, my mom, my dad, my sister, her son, and the most important is my Disabled husband who DSS has signed statement from a physician stating Jason Drake is not capable of throwing or pushing anything. Also the police department has unfounded and closed their case.

Also they(DSS) want to remove my two children from my mother's home because of a CVD charge on my DAD from 1998 of which had to deal with my brother you is now past away a year ago. But yet DSS is allow My Childs (Elizabeth Lawson) grandparents Shelley and Wayne Lawson keep a child in their home when both of them have a criminal history of drug charges. So if they do it for one they can for others.

If you go by the DSS calculator on the website your attorney is not following it at all. We I put in the number David Lawson should actually be paying more. Also cost of leaving as went up since my child support was originally done in 2007-2008 so they did not consider that either.
