Dear Mr. Blincow:

This agency, the Department of Health and Human Services, administers the South Carolina Medicaid Program. Your enclosed request for information was referred to this Office for a response.

You may be surprised to know that, generally speaking, the federal Medicaid statutes and regulations prohibit release of any information except for purposes directly related to the operation of the Medicaid State Plan (the document that sets forth, for federal oversight, the exact description of the State's Medicaid Program). 42 USC §1396a (a) (7) and 42 CFR §431.300 et seq. This statute and these regulations were in part a response to the historical stigma associated with receipt of medical and other forms of public assistance. Therefore, we believe that the exemption at S.C. Code Ann. §30-4-40(a) (4) would apply.

We would however, be happy to comply with a properly executed Authorization (copy enclosed) to release the information, or we can supply the information (if any is available) directly to Ms. Cornwall or her attorney. Please contact me if you have any questions. My direct is (803) 898-0062
