Per my message I left for you and as suggested by Kathy Sprayberry, I am forwarding this constituent's concern.

Ms. Brannon phoned to discuss a concern she has with water that is running across her property. Since 2006 she has been trying to have this corrected and a friend suggested that she call Senator Bright and ask if he could help her.

The property she lives on was her grandfather's and has since been owned by family members.

She shared with me that it all started after SCDOT placed large pipes to divert water along the road rather than allowing it to run down the sides of the road and disperse. The pipe was placed underground with the end left wide open and the water is shooting out and across her property. The water is causing property damage.

She would like something done to correct this. The response Ms. Brannon has received from SCDOT is that there is nothing that can be done, it's the way water flows; she says no, it is the pipe that needs attention. Perhaps extend it further down the road or redirect its path.
