Hi Elisabeth,

Thanks for providing us with the CWRC Funding Grid.

Ms. Koller has reviewed the grid and we have made changes to the DSS column. Ms. Koller noted that several of the participating agencies (including SCDE, the Technical College System, Department of Commerce and DHHS) are pledging State funds.

Per Ms. Koller, our agency has access to Federal Supplemental Nutrition Assistance Program (Food Stamps) Employment and Training funds that we believe could be used to leverage the State funding available for the CWRC initiative. Although we have estimated in the attached annotated grid that our contribution would be \$100,000, it is possible that it could be even larger than that.

Please let Ms. Koller know if you are interested in exploring this possibility and we will arrange for our SNAP consultant, Dr. Bill Benton, to contact you.
