Worried about the Affordable Care Act?

SCBIO Health Insurance Plan allows companies to lock in rates for 2014

While private health plans and company-offered health insurance have been in a roil because of the Affordable Care Act provisions, -- and delayed provisions -- the SCBIO health Insurance plans for member companies are showing they can hold or lower rates.

Members who sign up or renew can lock rates in through 2014 if companies sign before Oct. 1.

For two recent company renewals, the SCBIO plan offered a **7% decrease** in premiums and for another renewal, a modest 5% increase.

The President has delayed for one year employer mandates on insurance, but individual mandates remain, meaning **individuals must find insurance by 2014.**

The young, healthy and relatively well-paid can expect an unhealthy insurance cost increase. The sick, older, and poor, can expect help with decreases with possible subsidies from exchange insurance.

This "shifting " of premium costs from the sick and high -

risk individuals toward the young and healthy, could mean changes in group plans. One South Carolina official said: expect 60% rate increases for many plans. Three factors in equal measure cause the increase: the mandates to write coverage for pre-existing illness, the loss of community rating or underwriting, and new taxes and fees.

Lock in rates now, and give yourself a year to see what else shakes out.

Venture funds cashing in

Five Great Observations about the surge in BioTech IPOs.

1) There's no irrational exuberance for diagnostics or medical devices.

Of this group of 24 companies, 20 are drugmakers, three are diagnostics companies, and one was a contract research organization. None are developing medical devices.

2) The IPO money is being spread widely across the map.

3) A handful of venture firms are getting a lift: Several venture firms show up in the ownership tables.

4) A diverse cast of underwriters is getting in on the action.

5) Cancer, autoimmunity, and rare diseases are where investors want to play
