Katherine,

The South Carolina Perpetual Care Cemetery Board is created by §40-8-50 and is composed of 7 members appointed by the Governor. Three appointed members must be public members who have no financial interest in and are not involved in the management of a cemetery or funeral-related business, and four members must be owners or managers of cemeteries in this State who may be selected from nominees submitted by the South Carolina Cemetery Association. The current composition is as follows:

Public – John Bartus 12/19/02-12/19/06

Public – Roger Finch 12/19/02-12/19/05

Public – VACANT

Owner/Manager – William Floyd 1/1/09-1/1/13

Owner/Manager – Jacqueline Petty 1/1/09-1/1/13

Owner/Manager – Rick Riggins 1/1/06-1/1/10

Owner/Manager – James Russ 1/1/09-1/1/13

*Please note that the seats of those board members whose terms have expired are not considered vacant. Members of this board, in accordance with §40-8-50, are “appointed for terms of four years and until their successors are appointed and qualify,” meaning that they continue to serve in their positions until someone is appointed to replace them.
