I. Approval of Minutes of September 10, 1976, Commission Meeting

It was moved (Stanback) and seconded (Howe) and unanimously voted that the minutes of the September 10, 1976, Commission meeting be approved as written.

II. Appointments to Standing Committees of the Commission

Dr. Smith announced the appointment of Mr. Clement to the Committee on Academic Program Development and the Committee on Federal Programs, and the appointment of Mr. Swanson as Chairman of the Committee on Budget and Finance. Dr. Smith stated that, as Dr. Pratt succeeded Dr. Draffin as the ex officio member of the Commission representing MUSC's Board of Trustees, he had appointed Dr. Pratt to replace Dr. Draffin on the Committee on Academic Program Development. The revised listing of Standing Committees is attached as Exhibit A.

III. Presentation of 1977-78 Appropriation Requests by Presidents of South Carolina Public Colleges and Universities

Dr. Smith welcomed the presidents of the public senior colleges and universities who were scheduled to present their 1977-78 appropriation requests to the Commission at this time. Mr. Jennings presented an over-all analysis of the budget requests, a summary of which follows:
