
Thank you for sharing your concerns about the current plans for downsizing the Navy.


It was good to hear from you again. My loyalty will always be to the Navy that you and I served in, and I regret that it appears that the Navy will be reduced in the coming years.

Dear Admiral Byrd:

I am in receipt of your reply to my inquiry concerning our reduced number of ships in the FLEET.

Your letter was well-written. My concern is what you consider "acceptable" risk! I am not denying the fact that the United States has a "high tech" Naval force. I also am not denying the fact that our sailors are extremely capable and professional. The following are my concerns about a navy with less than 600 ships:

- 1. The former Soviet Union could revert to the old communist system if the transition to a democratic society fails.
- 2. China is not a "bedfellow"; they could expand at any time due to our reductions in the military.
3. No matter how professional we are, you cannot overlook numbers. If you have one ship on the line and your enemy has two or three, you will not prevail in battle, regardless of technology.
4. Today's "budgetary environment" must not be used as an excuse to reduce our country's forces to rubble. From the reports I hear and read about in the media, the military in general is moving in a bad direction.
5. We must not repeat the cycle as before. Every time we reduce, we get caught with our pants down.

In conclusion, I thank you for responding to my Senator's inquiry on my behalf. Perhaps the trend can be reversed.

Dear Mr. Chairman,

Thank you for your letter of August 7, 1998 regarding the correspondence from your constituent, Mr. George W. Stuber, case number 391887. I am responding on behalf the Office of Legislative Affairs.

Mr. Stuber addressed concern over Navy Force Structure falling below 600 ships. He made reference in his letter to the Bottom Up Review, which was a strategic evaluation of our Nation's forces conducted in 1993. As you know, this assessment was repeated four years later in 1997 and published as the Quadrennial Defense Review (QDR). The QDR evaluated the post-Cold War threats facing the U.S. and determined that the Nation required a fleet consisting of 12 aircraft carriers, 12 Amphibious Ready Groups, 50 attack submarines, and 116 surface combatants. These numbers were confirmed in an independent evaluation by the National Defense Panel (NDP) in December of 1997.

While we must be careful to balance our world wide commitments against acceptable risk arising from reduced force structure, a 600 ship Navy could not be sustained in today's budgetary environment.

Today's U.S. Navy has 339 ships in commission. This includes 12 Carrier Battle Groups and 12 Amphibious Ready Groups. Our Navy is 'on watch' and



Recently, I read a most interesting book - *History of The U.S. Navy* - by James M. Morris (1977, revised edition). To my astonishment, this record has revealed a distressing pattern of neglect towards maintaining an adequate Naval force to accomplish our goals and properly keep our sea lanes open. Time and time again, our forces have been cut to the bone in order to allow other priorities to prevail. This really concerns me. The following is a direct quote from this book which is found on page 247 (*The State of the Navy*).

According to the Bottom-up Review plans for 1999, this number will then stand at 452 - 462. Included will be a drop in strategic missile submarines from 35 to 17, attack submarines from 97 to 44 - 55, fleet aircraft carriers from 15 to 11, and surface ships from 427 - 346. Furthermore, with an estimated ship-life of 30 years for the Navy's existing vessels and with the Navy's ship-building program reduced to an average of six new ships per year joining the fleet during the mid-1990's (down from 20 ships per year during the 1980's), it can be calculated that the Navy will have only 180 combatant ships afloat within a short period of time.

If half of the information above (and elsewhere) is correct, we (our Nation) will be placed in "harms way" by any two-bit adversary. Our Naval forces should **never** fall below 600 ships (of all types). No matter how sophisticated our technology, there is no substitute for numbers.

In conclusion, I would like to urge a complete "rethinking" of our Naval commitment. We don't need to repeat history by being totally unprepared for new emergencies.

Dear Governor Haley,

The Community listening session at the Shandon Baptist Church yesterday was most informative, and disappointing!

This is the second time, during my lifetime - where the "Powers in Washington" want to reduce spending and balance the budget at the expense of our National security. The first time was during the 1990's.

Enclosed are copies of my letters sent to our senators during that period. Most responded in the usual "political" letter format. However, the end result was the closing of our Navy base in Charleston. It took several years to recover from that closure.

There is another issue which is more important that needs addressing - National Security!!

As noted in my letter of November 9, 1998, to Rear Admiral Byrd, my concerns in items 1 and 2 are noteworthy. Now we can add to the list our fight against terrorism, both here and abroad!!

Yet - the cycle of reduction is again
