I spoke with the staff at Tri-City and they believe that the walk-in cooler will hold all of your items from Monday to Tuesday. It will be easier for you to pick up and we can make certain that we have everything and/or have time to take care of any problems.

We will pick up your order on Monday, May 6 at US Foods. We will thaw the frozen items overnight so that they are ready to use on Tuesday. You can pick up as early as 7 or 7:30 AM on Tuesday. We will put the cold items into a couple of Cambros to help maintain temperature. They are heavy and will require two people to unload them. They should fit into the Durango.

I need to order the frilled toothpicks and SC napkins (if you want them) today as they come via UPS. I will order the rest of the paper goods/supplies next week on Monday to come in with our regular Wednesday delivery on the 1st, and then get all of the food items on Monday, May 6.

If you like, you can fill a couple of your coolers from our ice machine Tuesday morning.
