Subject: Support Request to Prevent Possible Shaw Air Force Base (AFB)
Mission Delay

Dear Honorable Heigel

I respectfully request your assistance to expedite Shaw Air Force Base's pending air permit modification with your Bureau of Air Quality (modification to Permit # TV-2140-004). The modification is necessary for Shaw to use a new Abrasive Blasting Unit (ABU). Shaw is unable to perform proper corrosion control and treatment of over \$3.3B of aircraft parts and support equipment components without use of the ABU. Any delay in processing this permit puts Shaw's critical national defense mission at risk.

Your Engineering Services Division Director, Steve McCaslin, and his manager of the Sandhills Section, Christopher Hardee, have worked closely with Shaw staff on this issue. Through this collaboration, it has been determined the permit for the ABU meets the requirements for a minor permit modification, potentially reducing the timeline from up to 120 days to potentially less than 21 days. The approval of this reduction is currently in the SCDHEC staffing process.

Any assistance you are able to provide to expedite the permitting process and the ABU operation would be greatly appreciated. Please convey my sincere thanks to both Steve and Christopher for their quick work.

Lt Governor Bryant,

Sir, thank you for your visit to Shaw AFB, we appreciate you taking the time to learn about our Mission and our Airmen. Since your visit, an issue has arisen that I'm requesting your help on.

BLUF: Our sole maintenance large media blaster booth is currently non-operational due to a pending Title V Air Permit issued by the South Carolina Department of Health and Environmental Control.

DISCUSSION: Our Team missed the requirement to renew our Air Permit with the State and a permit typically requires 120 days to issue from the time of application, which poses a risk to the 20 FW's mission. The blast booth is utilized for paint removal operations of \$ 3.3B of large aircraft parts and support equipment, 850 pieces of which are either due or overdue for refurbishment. By delaying refurbishment we risk having significant mission equipment in an unserviceable/useable condition.

REQUEST: We understand the demands on DHEC's time and take full ownership of this dilemma so any assistance you are able to provide to expedite the process is much appreciated. Please let me know if you have any questions and thank you for your consideration.
