South Carolina is making it easier for military men and women who drove military trucks and are hanging up their uniforms to get a civilian driver's license for commercial vehicles, officials announced Thursday.

**Note:** In February, Gov. Nikki Haley announced "Operation Palmetto Employment." It features a website that lists multiple information and education sources for finding civilian employment to help members of the active duty military or National Guard and Reserve, or members of their families.

**The State:** House passes its own version of statewide reading intervention program

The S.C. House on Thursday passed its own version of a bill aimed at reforming the way public schools teach reading. Called the Read to Succeed Act, the bill would create a statewide emphasis on reading by requiring districts to develop reading plans.

**Note:** Gov. Nikki Haley recommended -- and the House approved -- more than \$30 million in new money for reading coaches and \$4.5 million for summer camps in the state's budget starting July 1.

Republican Gov. Nikki Haley raised more than \$860,000 during the first three months of the year and had \$4.27 million on hand as of March 31 for her re-election bid, her campaign said. The first-term governor from Lexington has raised nearly \$6 million during the cycle.

A national report this morning ranks South Carolina "near the bottom" in treatment of mentally ill inmates.

The report by the Treatment Advocacy Center and the National Sheriff's Association found the state ranked near bottom in the availability of public psychiatric beds, efforts to divert mentally ill from imprisonment, per capita spending on mental health "and almost every other measure of treatment for mentally ill individuals."
