On the above date and approximate time:

I, Lt. Garvin while at the front gate assisting with processing visitors heard Officer Diamond give the visitors a courtesy before letting them in about excess jewelry and necklaces. At approximately 1:35 pm an unidentified black female entered the front lobby to be processed with a necklace tucked into her shirt. I asked her if she could pull the necklace from her shirt. She was wearing a sterling silver with no religious crucifix. She also had on multiple rings. The unidentified female then began getting very hostile. She was asked was it her first time visiting an SCDC facility and she said, "no!" She was then informed that she would not be able to visit due to her being in violation of agency policy. She was asked for her I.D. and the name of the inmate that she was coming to visit, but she refused. She then stated very loudly, "all I want you to do is open this fucking gate to let me out!" I opened the door and asked Officer Orland to open the gate so she could leave. As she was walking out of the gate she turned to me and said, "you fucking peasant!" She also stated, "you all are just a bunch of stupid motherfuckers that work here!" The unidentified female came back to visit on Sunday, November 15, 2015 and was identified as Arthurine Stanton mother of inmate Cory Stanton SCDC # 363671. -----End of Report-----
