On July 7th, 1939, The Housing Authority of the City of Columbia, S.C. petitioned this Court for the appointment of a Condemnation Board, reciting that it was preparing to erect in the City of Columbia, S.C. a housing project pursuant to the provisions of Act No. 783 of South Carolina, Statutes of 1934, and that property belonging to William Thompson and all other heirs of Harriett Thompson, deceased, fully described in that petition, was necessary for carrying out this public purpose. Whereupon this Court, by its order of July 7, 1939, appointed W. L. Bennett, R. E. Carwile and John H. Bollin as a Board of Condemnation, pursuant to that statute. Notice of the resolution and of this order and of a proposed meeting of the Condemnation Board was given to William Thompson, Rebecca Williams, Hattie Keitt and Fannie Caldwell, heirs of Harriett Thompson, and on the Tax Collector for Richland County and the City Sheriff, as shown by the affidavits of service endorsed on the back of the petition, order and notice and attached thereto.

Thereafter, a hearing was had before the Condemnation Board, pursuant to Notice, on the 4th day of August, 1939, at which time testimony was taken as to the value, after

which the Board, by its finding of August 4, 1939, found that the fair value of the property to be taken was \$1300.00, notice of which was given to The Housing Authority of the City of Columbia, S.C. and to Melton & Belser, Attorneys for William Thompson and others.

On the 11th day of September, 1939, The Housing Authority of the City of Columbia, S.C., as will appear from the receipt of the Hon. Clarence E. Hinnant, Clerk of this Court, deposited with this Court the sum of Thirteen Hundred (\$1300.00) Dollars, representing the award by said Board, and on the same day gave notice to counsel for William Thompson and others of the said deposit and of the fact that pursuant to the statute title to the property at the time of the deposit passed to The Housing Authority of the City of Columbia, S.C., with the right on the part of that Authority to immediate possession.

In the same instrument The Housing Authority of the City of Columbia, S.C. gave notice that it would apply to this Court at the time set out in the notice for an order confirming its title to this property, and directing the Clerk of this Court to execute a proper deed to The Housing Authority of the City of Columbia, S.C., as evidence of its title, vesting in it all of the rights of William Thompson and all other heirs of Harriett Thompson, and all other persons having any interest in the property.

Now, therefore, after hearing, it is

ORDERED AND ADJUDGED:

1. That the title to The Housing Authority of the City of Columbia, S.C. in and to the following described property:

All that piece, parcel or lot of land with the improvements thereon, situate, lying and being on Forest Drive in the City of Columbia, County of Richland, State of South Carolina, containing approximately one-fourth of an acre, being rectangular in shape, measuring on its Northern and Southern sides 52 feet, 2 inches, and on its Eastern and Western sides 208 feet, 8 inches. Bounded on the North by Forest Drive; on the East by property of Campbell; on the South by property of Doby Estate and West by property of Brown.

be and hereby is confirmed.

2. That the rights of William Thompson, and all other heirs of Harriett Thompson, and of all other parties having any interest in the property hereinabove described, have attached to the money deposited in the hands of the Clerk of this Court in accordance with their respective interests as of the date of said deposit.

That the Clerk of this Court do forthwith execute to The Housing Authority of the City of Columbia, S.C. his deed transferring the property hereinabove described to The Housing Authority of the City of Columbia, S.C., in fee simple, and that the rights of William Thompson and all other heirs of Harriett Thompson, deceased, and of any and all other persons claiming any interest, lien or right in this property be and hereby are forever barred.

BY MR. DREHER:

Q. Did you and Mr. John C. B. Smith, another real estate man of this City,
make an appraisal of lot No. 17 on the white site?

A. Yes, sir.

Q. Will you give us the amount of that appraisal and how you arrived at it?

A. The appraisal as set forth in USHA Form 424, dated January 18, 1939, shows
value of land \$1250.00 and \$50.00 for improvements, making a total of \$1300.
Assessed value \$150.00. The value of the land was related to \$20 per front
foot, the dimensions being 52' front and an average of 212 in depth. With
regard to the street the land lies well and can be advantageously improved
without any unusual expense, in consequence of which the value is slightly
in excess of \$20 per front foot was ascribed to the land. The only im-
provement observed is a commercial type building, which apparently has been
used as a dwelling - is in very poor condition and would not ordinarily be
regarded as habitable. There appears to be water services available to the
property, but I am not sure is directly connected with the City system,
therefore, no value for this water service was ascribed.


