According to the Eleventh Judicial Circuit Public Index, you were the judge assigned and disposition judge for my case. That is why I am addressing this letter to you.

After going through 4 weeks of training with TransDev (contractor with MetroAccess in the Washington DC Metro Area) and passing all written and driving tests, a physical and drug test; I was notified on July 21, 2015 by their Human Resources personnel that my background check came back stating that I had a charge on my criminal record from the state of South Carolina (Edgefield County). I was asked about it and told them that I pleaded guilty to trespassing. I was told that according to my background check, I had accepted a plea bargain for assault/assault and battery 3rd degree. I was told that if I could get everything rectified within a week, I would be welcomed back.

After being devastated about hearing this news, I began searching the Internet and talking to lawyers to see what can be done about the situation. I was told that if I had taken a plea, then there should be a transcript because a judge/magistrate, solicitor, my court appointed lawyer and a clerk/stenographer should have been present. Online it says in order to get a transcript of your case, first you had to look up the case and the clerk that recorded the case should be highlighted in blue. (1) There is no clerk listed. (2) The agreement was between my lawyer (W. Greg Seigler) and I. I never stood in front of a judge or magistrate to make sure that I understood what I was pleading to. My lawyer said that if I took the plea for trespassing that I could be released that day with 30-days time served. I accepted and was released later that day on October 3, 2012.

To my surprise on July 21, 2015, I learned that what I was told I was pleading guilty to was not what was listed on my criminal record; which is the reason for this letter. Since I no longer reside in South Carolina, my first step was to begin looking up the phone numbers to the court houses, solicitors, magistrates, Governor, etc.; to whom I could get to help me. On July 22, 2015, I spoke to a Clerk in Edgefield County and found out that the current sessions are being held in Saluda County. The clerk looked up my court case and couldn't find any transcripts or documents and gave me some other people and numbers to contact. I contacted a lawyer that helps inmates that I had written to while being incarcerated in July-September 2012 and he pulled up my case. He found a lot of discrepancies and couldn't exactly tell when I

was released...it looked as though I was indicted after I was released. Since I was no longer an inmate, he couldn't really give me much information, so he referred me to Mr. Castro. He too was having a hard time understanding what was entered into the database regarding my case. I called my lawyer (now Family Court Judge) at the time W. Greg Siegler's office and was told he was out of the office and would be back the following day between 9-9:30 am. When I called the office back on July 23rd, his receptionist recognized my voice and told me that Mr. Siegler would not be accepting my calls.

So, after calling around and speaking to clerks in Edgefield, Lexington and Saluda counties and them all being confused about what has been entered into the SC database, I was passed around to person after person. So, I decided that I needed to write a letter and send (fax) it to the Governor of SC, the Head Solicitor Donnie Myers, the Edgefield County Clerk's Office, Edgefield County Office of Magistrate and the Solicitor's office to name a few. The letter was faxed on June 24, 2015.

On Monday, July 27th, Melanie Smith, from your office, called in regards to my letter. I explained to her that my job was in jeopardy because I pleaded guilty to trespassing but online it says assault and I needed it to be removed. She said sir, I am looking at the database and see that you signed off on the assault charge and not trespassing. I asked her to fax me what she sees on the screen. My signature is not on any of the attached sheets that were faxed to me. **(Attached)** I emailed those papers to Mr. Castro and he didn't see my signature on any of the sheets either. He was very helpful and was willing to talk with TransDev Human Resources Personnel on my behalf, but if the assault charge is not changed to the charge of trespassing that I had agreed to, then it would be useless.

On Tuesday, July 28th, I received a call from someone in the South Carolina Governor's office (803-734-5049) regarding the letter, after explaining the situation, he transferred me to someone else, and that person transferred me to the Records Department and she told me that the only thing she has are my fingerprints.

I have talked with a lot of people in the South Carolina courts whether it's a lawyer, solicitor or clerk and they have all been helpful, each have tried to help me as much as they could. It seems that no one wants to really tell me everything because they are confused about how things were entered, not seeing the proper paperwork, can't find transcripts, etc. **Since, my job have been lost, I would like to know what it is that I need to do to rectify this situation for future employment.** Is there a case law that would substantiate the meaning of my case/charge as far as trespassing and assault/assault battery 3rd degree as meaning the same thing?
