Dear Senator Verdin,

I am writing in regards to an urgent request. I am a respite care provider for my grandson Chad Burrell, Jr. Chad is 9 years old and has cerebral palsy. He is unable to walk or sit independently therefore, he is totally dependant on his caregiver for mobility. I care for Chad on a regular basis in my home which is certified by Greenville County Disabilities and Special Needs. Chad's parents are divorced and his father has custody of him. Chad stays in our home one third to one half of the time.

My problem is getting him in and out of the house. Chad weighs approximately 60 pounds. To get him in the house I must carry him up 2 flights of stairs. The height of my home requires a lift because a ramp is not practical. GCDSN had this issue assessed recently and the result was a recommendation for a platform lift at the back entrance. We have been waiting for months to get approval for the lift. Because it is equipment that could be moved to another location if needed I believe it can be categorized as assistive technology. If the lift is purchased under this category it would not exhaust Chad's lifetime Medicaid allowance for home modifications. The lift will cost approximately \$12,000. Chad's lifetime cap for home modifications is \$7,500.

Please help us get this approval. Carrying him up and down 2 flights of stairs is very dangerous. Also if we had an easier way to get Chad out he could enjoy more of the outdoors. Thanks so much for your help.
