This month we are proud to have Rick C. Wade as our honored guest speaker. A native of Lancaster, SC, Mr. Wade attended USC to receive his Bachelors in Biology. He continued his education at Harvard University's Kennedy School graduating with an Master in Public Administration. Mr. Wade put his education to use by serving as the Chief of Staff to Lt. Gov. Nick Theodore, and holding a cabinet position under Jim Hodges as the State Director of the SC Department of Alcohol and Other Drug Abuse Services.

More recently, Mr. Wade severed as a Senior Advisor to President Obama, and severed as the Deputy Chief of Staff to the Secretary of the Department of Commerce, Gary Locke.
