The SLED agent also told the owner that she would have to re-apply for the liquor license. I'm not sure why there are SLED agents telling the owner this, but that's the story I'm being told.

Honestly, I have no idea what is going on. I cannot get a clear story from either party. I don't know what the problem is that DOR is running into with the application process, but I needed to give you this information. Please advise on how to proceed.
