Dear Governor Haley:

We see from your website that South Carolina's unemployment rate sits at 5.6 percent, one of the lowest rates since 2001. "In the last two years, we've saved businesses more than \$151 million in unemployment taxes. We have cut our debt service by almost half over the last five years, while at the same time doubling our General Reserves. We've moved almost 30,000 people from welfare-to-work. 2015 was the third year in a row with record-breaking tourism. And there are more people working today than ever before in the history of South Carolina." Announcements like Blackbaud, the leading provider of software and services for the global philanthropic community, which is expected to create 300 new jobs over the next five years, continue the economic growth in South Carolina.

The South Carolina economic development message must be communicated to business decision makers to put South Carolina top of mind. We understand that you are serious about creating growth and economic activity in South Carolina, and we feel that the time is right for a partnership between South Carolina and *FORTUNE* magazine to deliver your economic development message to a key audience of business leaders.

We are proposing a South Carolina economic development section in *FORTUNE* magazine during 2016 extolling the benefits of doing business in South Carolina. 
