Ma'am,

I am a highly decorated Army Veteran, whom spent a short tour in the South Carolina National Guard. I'm seeking an office call (meeting) in reference to unfair treatment and discriminatory practices from the South Carolina National Guard. I have made all efforts to peacefully negotiate with parties involved, with no result. Before my case goes public, I'd like to present evidence as it pertains to my case, as well as a description of the acts that lead up to my separation from the National Guard. The same individuals whom have continuously persecuted me are the same persons whom have utilized state funds for their leisure, conducted sexual misconduct, conducted actions unbecoming of an Officer, and conveyed preferential acts for others gain. As previously stated, I'm ready to present this dilemma before you and my legal or NAACP representative for action, before all evidence goes public. I have enclosed partial evidence to the change of my military status. This change in my military status is not what was previously agreed upon and has hindered me from completing military service and now retirement. Your attention on this matter would be most appreciated.




