Mr. Hucks...

First, I have never refused to comply with a request from you for access to public documents. My responses to your previous requests have been prompt and timely, in keeping with the requirements of the South Carolina Freedom of Information Act.

Second, you requested Mayor John Rhodes' travel expenses for his trips to China at 10:30 a.m., Wednesday, May 18. That was four days ago. Your second request came an hour later and was amended to include Mr. Rhodes' expenses for "all of his international travel" during his term as mayor. For the benefit of those who are on your CC list, I am attaching those earlier e-mails to this message. Your third request – unchanged – arrived tonight at 8:44 p.m.

Third, in response to these multiple requests for access to public documents, I am hereby attaching the mayor's travel expense reports for seven trips to China and one trip to Ireland. Note that some of the amounts listed on the attached receipts are in Chinese yaun, not U.S. dollars. The city did not have expenses for the mayor's other trip to China; consequently, no report is attached.

Fourth, several local news media and at least two members of the public did make such requests for these documents some weeks ago, and I responded in a timely manner with the same information attached here.

Finally, this completes my response to your requests of March 18, March 18 and March 22, 2016, for access to public documents under the South Carolina Freedom of Information Act, well before the 15-working day deadline of June 8, 2016.

Mark - the law is on our news team's side here as to your responsibility to provide these requests. The last time you refused to comply, we were required to forward our request to legal. This does grow tiresome and impedes with the public's need for timely information.
