Tonight, South Carolina voters will see why CVSC endorsed Senator Vincent Sheheen when the gubernatorial candidates take the stage in North Charleston. As our Board Chair Jay James said last February, "Vincent's commitment and passion for conservation is from the heart."

Tom Ervin's entry into the race as a common sense petition candidate is worth noting, but polls confirm that the choice is between Sheheen and Haley. The contrast could not be more clear. Haley ignores conservation. Sheheen

champions the Conservation Bank. Haley questions environmental regulations. Sheheen sees clean air and water protections as a core function of government. Vincent Sheheen will protect the South Carolina we love. You can watch the debate on WCIV in Charleston, WACH in Columbia, WPDE in Myrtle Beach, WLOS in Greenville and on C-SPAN nationally.
