A CALLED MEETING OF THE ANDERSON COUNTY COUNCIL WAS HELD ON MARCH 6, 1986 AT 5:00 P.M. IN THE ANDERSON COUNTY COUNCIL CHAMBERS - ROOM 109. CHAIRMAN HAROLD E. BEEBE PRESIDED.

Mr. Beebe called the meeting to order and Mr. Watson gave the invocation. Everyone stood and pledged allegiance to the flag.

Mr. Mullinax presented second reading of Ordinance #196 approving and granting consent to the assignment and transfer of the Community Antenna Television franchise and system from Video Properties, Ltd. to Northland Cable Television, Inc. Mr. Hooper moved that the ordinance be approved on second reading as presented. Mr. Cox seconded and vote was 5-0.

Mr. Mullinax read a letter from John A. Holman expressing opposition to closing Hiott Road, county road #C9-206, in Anderson County. Mr. Mullinax was also asked to read a letter from all members of the Legislative Delegation granting written approval of the County Legislative Delegation pursuant to Section 7-13-1310 of the S.C. Code of Laws for the County to purchase a "punch-card" voting system.

Mr. Watson said the first budget workshop in about two weeks.

Mr. Mullinax informed Council of current pending legislation which would create a state funded Water-Sewer Grants Program and suggested that Council pass a resolution (#322) supporting the Water-Sewer Grants Program to be controlled and funded by the State Budget and Control Board. Mr. Hooper moved that Resolution #322 be approved supporting this program. Mr. Cox seconded and vote was unanimous.

Mr. Rhodes asked Mr. Mullinax to draw-up a resolution concerning Lottery - pro & con. The following news media were contacted concerning this meeting.
