**Greenville News:** State pays off unemployment loan early

South Carolina on Thursday made its final payment early on a federal unemployment loan that at one point reached almost \$1 billion, spanned the terms of two governors and spawned sweeping reforms of the way the state compensates the jobless. Gov. Nikki Haley announced the final payment, backed by lawmakers who helped craft the reforms, as well as business leaders and the director of the state Department of Employment and Workforce.

**Note:** "This is a fantastic celebration," Haley said. "We saved the businesses of South Carolina \$13 million by paying this off early."

South Carolina's unemployment agency has paid off its nearly \$1 billion debt to the federal government, five months ahead of schedule. Gov. Nikki Haley announced that the Department of Employment and Workforce made a final payment Thursday of \$120 million. Director Cheryl Stanton says that means her agency is debt free.

Five months ahead of schedule, South Carolina's unemployment agency has paid off a nearly \$978 million loan that helped the state cover jobless claims during the Great Recession. The S.C. Department of Employment and Workforce on Thursday made a final \$120 million early payment to the U.S. Department of Labor, repaying the debt.

**Note:** "A billion dollar loan is no small loan," Haley said, adding that the early payoff saved state businesses more than \$12 million in interest payments.

A decision to keep the troubled South Carolina State University's accreditation on probation removed an immediate threat of forced closure. Acting President Franklin Evans announced Thursday that the Southern Association of Colleges and Schools' Commission on Colleges decided to keep South Carolina's only public historically black university on probation as its newly appointed board seeks to return the 119-year-old school to fiscal solvency.

Boeing officials in South Carolina are looking into the cause of a nitrogen line rupture that left a small crater on the company's North Charleston campus. Company spokesman Rob Gross tells local media outlets there were no injuries or health risks when the line between two buildings ruptured about 6:30 on Thursday morning. He says the nitrogen was immediately turned off and the company is investigating the cause.

A Republican senator seeking his party's 2016 presidential nomination introduced a bill Thursday banning most late-term abortions and is predicting the Senate will vote on the highly polarizing issue this year. Lindsey Graham, R-S.C., offered little sympathy for candidates who would rather avoid the issue.
