**Consideration of Centers of Excellence Appropriations Request
FY 2004-05**

Background

The Educational Improvement Act of 1984 provided for the establishment of a contract program with public or private colleges in South Carolina to foster the development of "Centers of Excellence" in particular areas of need related to teacher training. Last year the Commission issued revised *Guidelines* that had a different focus for the program. The revised program now focuses on teacher training linked to the State's low-performing schools and districts. The program's goals are to improve teacher quality and raise student achievement at the target schools and districts. State funding is now provided for up to five years with the goal of establishing statewide resource centers that will have a positive impact on the State's most needy schools and children. There are currently seventeen Centers of Excellence, although only four are receiving funding during the current fiscal year (FY 2003-04).

Program *Guidelines* stipulate that each Center submit budgets for the first five years of funding. Reporting requirements in the *Guidelines* further stipulate that each year there is a formal request for funding.

Budget Summary for Funding Request for FY 2004-05

This report outlines the appropriation request for FY 2004-05 that will be made to the General Assembly through the Commission's annual report to the Education Improvement Act Subcommittee of the Education Oversight Committee. In FY 2004-05,

the Commission will be funding one Center under the "old" Guidelines which will be in its third year of funding. In addition, two Centers under the "new" Guidelines will receive their second year of funding. The Centers of Excellence received \$500,226 which represents level funding since the \$26,624 budget reduction in FY 2002-03.

Noted in the table below is an itemized list of the Commission's total appropriation request. We are seeking a \$185,431 increase in funding for the program for FY 2003-04. This request for an appropriation increase is to allow the Commission to award two new Centers that will focus on assisting the State's low-performing schools and districts. An increase of \$35,431 is necessary in order to fund one new Center of Excellence.

Recommendation

The staff suggests that the Committee on Academic Affairs and Licensing commend favorably to the Commission an appropriations request of \$685,657 for FY 2004-05 to fund two new Centers of Excellence under the program's new *Guidelines*.

The Committee will make its recommendation to the Commission on September 4.

The Report is presented in five parts:

The data for Parts II-IV, and the actual enrollment data included in Part I, were electronically supplied by the institutions via the Commission on Higher Education's Management Information System (CHEMIS).

In Act 359 of 1996, the General Assembly reiterated the importance of reporting admissions standards. Section 59-103-45 again directs the Commission to review minimum undergraduate admission standards.

Recommendation

The staff suggests that the Committee commend this report favorably to the Commission for transmission to the appropriate legislative bodies and the S.C. Department of Education in compliance with Act 629 and Act 359.

The Committee will make its recommendation to the Commission on September 4.
