SHIPs eliminated, SCSEP cut in bill

The Senate Appropriations Committee has approved an FY17 funding bill that cuts two critical programs for older adults. It would eliminate all \$52.1 million in funding for the Medicare State Health Insurance Assistance Program (SHIP) and cut the Senior Community Service Employment Program (SCSEP) by \$34.4 million.
