While Coastal Carolina University leaders are working to craft a funding plan for the school's football stadium expansion project that will satisfy the South Carolina Commission on Higher Education (CHE), the Chanticleers' fan base is trying to do its part as well. Frustrated that the CHE continues to withhold phase two state approval for the project, most recently denying it with a 9-4 vote last week in Columbia, the website CoastalFans.com has launched a petition to Gov. Nikki Haley that had already garnered more than 1,300 signatures as of Thursday evening.

Note: "We, the undersigned, express our support of Coastal Carolina University's request for expansion of Brooks Stadium and ask that Governor Nikki Haley intercede on behalf of the University," the petition states.

Gov. Nikki Haley's first veto of 2016 has yet to materialize, two days after the farm bill was ratified. By this time last year, Haley had already issued her first veto on a sales tax bill for Clarendon County. That veto stood and was not overridden by the General Assembly. But that's not what's expected to happen with the farm bill; lawmakers are aiming to vote down Haley's veto when both chambers return next week. Haley has five days — excluding Sundays — to sign the bill, veto it or let it become law without her signature. Haley has vowed to veto the bill, stressing farmers would receive a "bailout" and special treatment if it becomes law.

The Senate's judiciary chairman pledged Thursday to hold a hearing this summer on legislation extending the allowed time for background checks on gun sales, though he expects them to go no further. Sen. Larry Martin made the promise while persuading senators to advance a bill on concealed weapon permits. It came after Sen. Marlon Kimpson, D-Charleston, reiterated his pledge to block any pro-gun bill "until we have a hearing."

A proposal to tighten background checks before S.C. gun purchases will get a hearing this summer, the powerful head of a state Senate committee promised Thursday. In response, Kimpson threatened to block a proposal that would allow Georgians with concealed weapon permits to carry their weapons in South Carolina. However, after Martin's promise, senators agreed Thursday to debate the Georgia proposal.

Larry Martin, who chairs the Judiciary Committee, agreed to take public testimony this summer on proposed bills that could extend the time allowed for running a background check when purchasing a handgun from three days to up to 28.

Public schools must permit transgender students to use bathrooms and locker rooms consistent with their chosen gender identity, according to an Obama administration directive issued amid a court fight between the federal government and North Carolina. The guidance from leaders at the departments of Education and Justice says public schools are obligated to treat transgender students in a way that matches their gender identity, even if their education records or identity documents indicate a different sex.

Kansas is pursuing regulations that would give it one of the nation's toughest policies against allowing transgender people to update their birth certificates, prompting anger from advocates and threats of a lawsuit. State health department officials contend an existing agency regulation allowing amended birth certificates conflicts with state law and needs to be eliminated. The agency has been pursuing changes for months and could impose them within six weeks. The department's revised rules would allow a change only if a person or his or her parents could document that the gender was incorrectly recorded at the time of birth.

WSPA: SC prison officers say they aren't safe on the job

Current and former correctional officers at some of South Carolina's maximum security prisons said the job is no longer safe. Dwindling numbers of officers, combined with a more dangerous population of inmates have left some officers demanding help while Department of Corrections officials struggle to fill vacant jobs and provide support to the officers on the job. At Perry Correctional, 96 men and women guard nearly 900 prisoners, including some of the state's most dangerous inmates. More than a dozen current and former officers contacted 7News to talk about current conditions inside the prison. Leon Simmons spent 18 years working in state prisons, the last four at Perry, before retiring in March of this year. "It's not safe," Simmons said.

Note: "The state is no longer locking up as many people that we're mad at. We're locking up people that we're afraid of," said SC Department of Corrections Director Bryan Stirling.

The Citadel has drawn widespread criticism since announcing Tuesday that it has rejected an accepted student's request, which she based on her Muslim faith, to wear a hijab (head scarf) with her cadet uniform. The applicant now says she will give up the opportunity to enroll in the school in August because of its decision to deny her that exception to the uniform rules. A spokesman for the family of the applicant, who was not named, described them as "heartbroken."

Dylann Roof's defense team has opposed handing over what it called a "windfall of information" that would

help state prosecutors in the death penalty case. The 22-year-old is charged with 13 counts, including nine of murder, in the June 17 mass shooting at Emanuel AME Church in downtown Charleston. Prosecutors will seek his execution if he's convicted. His attorneys filed paperwork Wednesday in response to 9th Circuit Solicitor Scarlett Wilson's request for a summary of expected testimony by defense experts, a list of all witnesses and an independent mental health evaluation of Roof.

Ninth Circuit Solicitor Scarlett Wilson took the witness stand Thursday and fought off allegations that she has purposefully removed potential jurors from trials because they were black. Her testimony came in a post-conviction relief hearing for William O. Dickerson Jr., who was sentenced to death in a James Island man's 2006 torture and slaying. It marked the first time that Wilson has been compelled to take the stand in such a proceeding, though officials said the move is not a rare one for prosecutors. Her testimony also came while Wilson is staged to prosecute two high-profile murder cases with racial undertones: former police officer Michael Slager in the shooting of Walter Scott and avowed white supremacist Dylann Roof in the slayings of nine parishioners at Emanuel AME Church.

The prosecutor in two upcoming high-profile South Carolina murder cases says she has a "huge problem" with being called a racist and says it's immoral to select jurors based on race. The Post and Courier of Charleston reports (<http://bit.ly/1sjGW2G>) that Charleston-area prosecutor Scarlett Wilson testified Thursday in a hearing for William Dickerson Jr., a black man convicted in a 2006 slaying. Dickerson's attorneys said Wilson is seven times more likely to remove blacks from a jury than whites. Wilson testified the analysis looked only at race and not other factors.

The county is paying \$2.5 million and the foundation contributing \$800,000. The property is along state Highway 170 between Beaufort and Hilton Head Island.

Bidding in an online auction for the pistol former neighborhood watch volunteer George Zimmerman used to kill Trayvon Martin appeared to have been hijacked by fake accounts posting astronomically high bids. At one point early Friday, the bidding surpassed \$65 million with the leading bidder using the screen name "Racist McShootFace." The site later showed that account had been deleted. Other screen names of bidders on the site included "Donald Trump," "shaniqua bonifa" and "Tamir Rice," the name of a black 12-year-old who was shot and killed by Cleveland police in 2014 while playing with a pellet gun.
