Temporary moratorium on new seamless conversions

The process of seamless conversion—wherein an individual in a private insurance plan is automatically enrolled into that company's Medicare Advantage plan upon aging into Medicare—has faced scrutiny from advocates and beneficiaries alike. In a new memo, the Centers for Medicare & Medicaid Services (CMS) has announced it is temporarily suspending its acceptance of any new seamless enrollment proposals from Medicare Advantage plans, and will soon issue another memo clarifying current policy.

Social Security announces 0.3% COLA for 2017

The Social Security Administration recently announced that beneficiaries could expect a 0.3% cost of living adjustment (COLA) in the coming year. Because the COLA has implications for Medicare premiums and deductibles, we are awaiting a formal statement from CMS regarding how much Medicare beneficiaries will pay for Part B in 2017.
