Dear Executive Director/Personnel:

Fairly recently I have been in contact with the D.C. Branch - as with the S.C.  
branch - of The Department of Health and Human Services. As with both branches  
of HUD and other assistance agencies.

It is by returned correspondence and referrals from the S.C. Dept. of HHS (Deputy  
Director, Alicia Jacobs and Bureau Chief, Garnell Cauley) that I currently inquire  
to this Office for further Information and any Assistance.

Without averting to the overwhelming details surrounding my pendant predicament;  
except to say that I have been imprisoned for over a consecutive thirteen (13)  
years now within the SCDC, and that I begin service of this sentence at the age  
of eighteen (18)--and am now thirty-one (31) years of age.

That said, I am about to be released from confinement with absolutely nothing,  
and nowhere to go; and in accordance with the S.C. Freedom of Information  
Act, SC Code Ann. §§30-4-10 through 30-4-110 (incorporated with 5 U.S.C.A. §522  
FOIA), and disclosure or dissemination Code of Federal Regulations [C.F.R.]  
applicable--namely pursuant to 42 USCA §2942 et seq.--I am respectfully  
requesting the following as referenced above:

1. Any and all Information, Applications needed, Brochures and Eligibility  
Requirements relating to offered or Available Community Grants, Vouchers,  
or Benefits Programs offered or extended through this Office of  
Economic Opportunity targeted for the Disadvantaged, Low-Incomed,  
Unemployed, Ex-Felon just released, Homeless and Disabled etc. (See  
S.C. Code Ann. §34-43-10 et. seq. and §34-43-20 et. seq. (as amended));
2. Any and all available Information, Applications, and Eligibility  
Requirements relative to State or Federally Funded and Regulated  
Economical Development Assistance cash grants, vouchers, or other  
assistance pursuant-but not limited-to 42 USCA §2977 et seq., §2965  
(Duty To Carry Out Programs), and S.C. Code Ann. §41-43-10 et seq.,  
§13-1-10 et seq., and the Community Economic Opportunity Act of 1983,

S.C. Code Ann. §43-45-30 et seq.; a Catalog Of Federal Domestic Programs, as with any relative Programs;

3. The active/current street and mailing address for the S.C. Inspector General's [Mr. Jim Martin] Office, as with the current street and mailing address for the S.C. State and Rock Hill Regional 'Economical Development Office'; as with any necessary Applications and Forms for applying for Unemployment Benefits or Unemployment Insurance Benefits; and
4. Any other such Information and Applications, Eligibility Requirements and Forms needed for any other Federally funded/regulated Assistance, Vouchers, Grants or Benefits Programs available, known and or extended by this Office as it relates to the targeted groups herein-above mentioned, including (but not restricted to): Emergency Relief, General Relief, Economic Development Assistance, Rental Assistance Grants/Vouchers, Used Car Purchase Assistance/Voucher, Economical Opportunity Grants/Voucher, Grants or Vouchers for Cooking Utensils and Clothes etc.

It is my firm understanding that the requested Benefits and Assistance programs alluded to are Federally funded and regulated, as it may be dictated under the proffered provisions and the Social Security Act (42 USCA §301 et seq.), namely 42 USCA §601 and 2977 (R.C.W. 7429.105) and other applicable Code of Federal Regulations (C.F.R.).


I also believe that I am deemed to be 'Indigent', Disadvantaged (Minority), am Low-Incomed, Unemployed, Ex-Felon [upon release soon], and have a recurring Disability within the definitions of the prevailing Federal and State laws and regulations on the issue (accord S.C. Code Ann. §§34-43-10 et seq. (1976, as amended)). As with the State and Federal 'Americans With Disabilities Act' (ADA) of 42 USCA §2977 et seq. (as amended) (S.C. Code Ann. §§43-1-10 et seq.) and Social Security Act of 42 U.S.C.A. §301 et. seq.

As such, I am respectfully and urgently requesting any and all help, genuine concern and referrals, and assistance this Office is able and at liberty to extend to me in these regards -- responsive to my requests. Insofar as to provide me with aid, benefits or assistance until I am able to secure Gainful Employment and become Self-sustaining.

I am quite sure the information and details you provide will instruct me further as to the extent and duration of the individual Benefits, Programs, Vouchers, or Opportunities available. And, additionally, explain the underlying criteria and parameters.

While trusting your disposition will be reasonably timely and equitable, as I respectfully request. I thank you in advance for your concern, indulgence, consideration and any information and details to extend to me. A favorable disposition I will continue to pray for. Remaining
