SC DOT:

The South Carolina Department of Transportation Commission on Thursday, Jan. 21, 2016, unanimously elected Mike Wooten of the 7th Congressional District as the new Chairman of the SCDOT Commission.

The Commission also unanimously elected John N. Hardee of the 2nd Congressional District as the new Vice Chairman of the SCDOT Commission.

Unsafe Tire Bill

Lewis Gossett called our office about H.3430, the Unsafe Used Tire Bill, and Continental Tire reps have sent me info on the bill. This bill would make it unlawful to install or sell a tire that the person knew or should have known is unsafe, which is defined in the bill. According to Lewis, the used tire sales industry and junkyards oppose this bill. Senator Sheheen has added his name to the bill and apparently refuses to take it off to allow for debate. Recall, last year the

Chamber of Commerce pushed this bill and our office decided not to get involved. The SCMA and tire companies seem to think the DMV currently has the statutory authority to address this issue through regulation and are asking for our help with DMV. According to Lewis, the tire companies may ask you for your help when you have dinner with them Tuesday night.
