Dear Mr. Estes:

I have received a reply to my inquiry from the United States Postal Service. They advised us of the following:

Below are details on why the current location for the collection box at the Ware Shoals Post Office will be permanent.

A drive up box on the street was not allowed by the city because of safety/traffic flow issues. Maintenance will have a handrail installed for easier access up the one step to the door of the post office by the end of this week.

A collection box must be present in front of the post office for customer service, as with all offices. USPS doesn't place a new collection box unless mail volume warrants it, and Ware Shoals doesn't generate enough mail to qualify for a second box in another location. Minimum volume for a collection box to stay active is 200 per day, and the established location doesn't receive that amount.

Here are some facts that may be useful in understanding the legal obligations of the Postal Service related to accessibility at historic owned Post Offices such as Ware Shoals:

- *The United States Postal Service is subject to the Architectural Barriers Act of 1968 (ABA) rather than the more recent Americans with Disabilities Act of 1990 (ADA).*
- *USPS has a large inventory of owned Postal facilities that were constructed before passage of the ABA, and the Ware Shoals Main Office is one of these facilities.*
- *Owned facilities constructed before passage of the ABA are grandfathered, and current federal accessibility standards do not apply until the facility is altered.*
- *In the past, the Postal Service has conducted a variety of "voluntary" projects at older Postal facilities to improve their accessibility for customers and or employees when funding was available.*
- *Unfortunately, due to current financial and budgetary constraints, we are not able pursue such voluntary accessibility projects at this time. However, we will note this request, and may reconsider it in the future when the Postal Service does have the necessary financial resources.*

WS Postal Secretes Revealed

Items below have been derived from letters and documents previously given to elected officials within 29692 postal zone.

1. **Modifications will ever be allowed** to aid handicap or elderly persons.
2. **Post office has no Land** for Drive-Up Box; **State or Town should provide.**
3. 1st requested in summer of 2013; US Reps. Scott & Duncan got involved 2015.
4. **Box approved** by USPS Greater SC in Sept. 4, 2015 **but no Investigation of sites. They owned no land!**
5. Letter of Sep 4, 2015 states "Individuals may contact officials at the Ware Shoals Post office at **(CALL) (864)-456-7512, and they will make arrangements for anyone with special needs.**" I assume this is curb service.
6. Sen. Scotts on 11/16/15 **reports a serious deception involving USPS** that Box is in place and satisfied.
7. WS Council gave a Goolsby Location as reported by Observer in 12/16/2015, but was rejected by Post Office. **Postmaster was not present.**
8. **USPS has failed to answer a FOI as to ask for and rejected Sites. Postal matters are exempt from US Justice Department accountability.**
9. The **New Hand Rails** were required in 1973 per US Access Board.
10. WS council **sold Dewitt St, for \$4600 for Drive up banking.** Deed 8187. **WS continues not to voluntary provide a usable site for postal box to aid multiple Handicapped individuals.**
11. Letters from Duncan Feb. 17, 2016 and Scott March 2, 2015 both state: **a drive up box was not allowed by the city because of safety/traffic flow issues.** < Hansen is Chief Bloeker
12. The town could have used the \$4600 to voluntary find and build a site for all.
13. A postal Survey and map of 29692 in 2013 indicate 4938 delivery points and a population estimated at over 10,000 would benefit from a drive up deposit box. It is not about naming one person who would benefit. < Postmaster HANIS is Removed/Retired for his Actions
14. Scotts letter of 3/2/2016 states **the current (sidewalk) location will be permanent** a handicapped or elderly person will **still be required to leave their car to mail a simple letter. Ware Shoals deserves better!**
15. Two independent eye Witnesses report; #1 a person in a car was seen driving up on the Side walk location to deposit mail, #2 a person now pleased with the new box would drive his motor cycle up and deposit his mail. #2 - Hansen @ A local Hardware Store Approached me with his verbal Tyranny in front of multiple witnesses

Dear Investigators:

I demand a thorough and detailed investigation of the Mayor John Hanson of Ware Shoals, SC. As a seventy year old person who has lived in the area and invited to participate in Town affairs, seminars and youth organizations in the Ware Shoals area I have never been subjected to the intimidation and questioning by any other entity, police force or judge as the mayor has delivered. Hansen's actions have caused me great stress and concerns for others he controls by his words. If he had continued I would have sued him and the town as this happened outside the Town Hall.

This complaint is solely against John Hanson and his actions and bias remarks. It has absolutely nothing to do with the US Postal Service. In fact the postmaster has sealed his own demise by lying to Senator Tim Scott and his superiors. My personal involvement is documented in the attached Governmental letters.

Removed/Retited

Getting no credible answers from the post master, I located Mrs. Patty Walters who serves along with Marshall Webster and the Mayor on the Properties Committee. I gave Walters copies of all governmental documents starting in 2013. I ask her if she was aware of the planned box as she would have had to give the post office permission to use adjacent streets she replied no but we do need that for us older citizens.

My first cordial meeting with Hansen was in the drive way of his home with another man present on either Friday 27 th or Saturday 28 th. of November. My question was "do you have knowledge of the Drop Box or any direct contact by the Post master requesting a site". His answer was no. This is now confirmed by the fact the properties will consider this issue on the 7th or 8th of December to be presented on December 16 before all council members for a vote.

My knowledge is that multiple wrongs have been committed by Hansen. I do not believe Mr. Leagans or Mr. Landrith would have been so animate in their advice to me but are bound by ethics; they do know something. As for Police Chief Irick, I personally believe he holds knowledge of Hansen miss deeds but has to suffer the fact that he and his wife serves at the discretion of the mayor.

There is one other person who you should contact. I have not personally spoken to Ex-Police chief Calvin Culbertson, for months there were articles in observer about parking issues at Hansen's old address. I do know Calvin now had health issues but the timing of his resignation appears after Hansen becomes mayor. The truth is in the interview.

My friend Ronnie Davis (864-554-4217) who is also 70 relates an incident when Mayor Hansen appears at his home. Ronnie is not at home but Hansen warns his wife that he is receiving complaints about truck parking issues and he wants that to stop. According to Davis the Ware Shoals police force has never ticketed his truck or issued a warning. I do know he was not pleased by the Mayors visit.

Today I ask the Carolina Tool parts employee Tommy (864-861-7519) had he ever heard any comments about Mayor Hansen. To that he replied there are multiple older residents that dislike his administration. The facts from multiple sources can be verified if you diligently look.

Over the last 40 years I have continually been forced to involve myself in local matters that would have had a negative effect on my home, the nameless nearby residents and the entire population of Ware Shoals. My request actions are and were correct for the good for the entire Community. The postmaster has sealed his own faith as a federal employee. But do you have the power to at least investigate and correct the multiple abuses attributed to Hansen's favoritism and unquestionable dictatorial powers. Does another person as I have to fear a physical assault if he does not get his way?

My personal complaint against the mayor begins on Monday Nov. 30 as I went into Town Hall to request being placed on agenda to speak on the box issue if needed. At that time Heather fields was not present to schedule me. Mrs. Irick the police chief's wife informed me that the mayor was in, I related to her that I previously had spoken to him and proceeded to leave. As soon As I reached my car the Mayor came out and the confrontation began.

The key to the ethics violation is that he had no right to aggressively condemn me for the instillation of the needed drop box. The mayor prejudiced himself by repediately and boisterously shouting directly into my face three times "name one person that would benefit, name one". I gave him the name of Marion Butler who that morning ask me how the postal box was proceeding. ` Second he stated that he sees me walking just fine and "I had no need or reason of the drop box". I leave quite upset and greatly traumatized by his actions which bothers me even today.

Had he known my age and physical condition probably would have made no difference to his convoluted agenda. I have had within the last two years 2 leg surgeries and now on my third life sustaining pacemaker. I decided not to appear before council but chose to speak directly to all but one council person, Jack Sullivan who refused meeting. Only 3 members were informed of the conduct of Hanson. In Addition no member ever divulged specific details but did know of his demeanor.

The first I contacted after the shouting match was John Brown (864-993-8533). On his front porch he indicated to me that he knew of communications problems and that he only catered to those that did not question his actions. Again Mr. Brown knew nothing of the process that should have occurred over 4 months ago.

The second person directly contacted was George Leagans, (864-456-9507)who works at our Burton Center. I also told him of postal request and how Hansen acted calmly on our first encounter then abusive in the second shouting match. I related to him what was said to and the in your face manner. The only thing George said was" I know you probably will not press formal charges but you do need to report this to our Police Chief. I did report this directly in front of two witnesses. The lady officer heard most of my verbal report the officer outside only knew I was their.

The third and final Council member I related this information to was Roy Landreth(864-554-3567). Roy is given the same detailed information; on completion he correctly referred to our ethics laws and his inability to talk to other members or me about any issue outside of council chambers. Roy being a friend urged that I report this to The Ethics Commission.



Rules of Conduct

General Information

All public employees, public officeholders, and public members are expected to adhere to and follow the Rules of Conduct as outlined in the Ethics Reform Act. Anyone who is found guilty of violating these rules is subject to prosecution by the State Ethics Commission and the Attorney General's Office.

A public official, public member, or public employee **may not knowingly use his official office, membership, or employment to influence a government decision** to obtain an economic interest for himself, a family member, **an individual with whom he is associated**, or a business with which he is associated.

No public official, public member, or public employee **may disclose confidential information gained as a result of his responsibility as a public official, public member, or public employee that would affect an economic interest held by himself, a member of his immediate family, an individual with whom he is associated**, or a business with which he is associated.

A public official, public member, or public employee of a county or municipality, may not knowingly represent a person before any agency, unit, or subunit of that county or municipality.

I personally believe that Mayor Hansen deliberately approached me with the sole intent of intimidation. I do not know if he overheard my request to appear before Town Council; but that is the point he came after me. Mr. Hansen only duty was to approve a box location if the Postmaster had asked for one. (A Fact documented that no action was taken.) Hansen had no right ask me any questions. I believe that a mutual bond is between them solely that both are recent transplants from a northern state. It is definite that they at some point had conversed about issues only known by postmaster. Mr. Hansen as confirmed his stance on the box issue. Hansen crossed the line of ethics with his "NAME ONE" rant. He violated me personally and every local citizens under the American's With Disability Act. His comment to me was "I see that you are walking just fine and would have no trouble." I ask you did he ever consider the elderly, wheel chair bound or the sheer convenience that would resolve the fact that the Post office is Historic and has never had any device or plan to make it at least half way compliant to ADA.

This statute pertains to use of public office for personal financial gain, financial disclosure by public officials, members and employees, campaign finance practices, and lobbying activities.

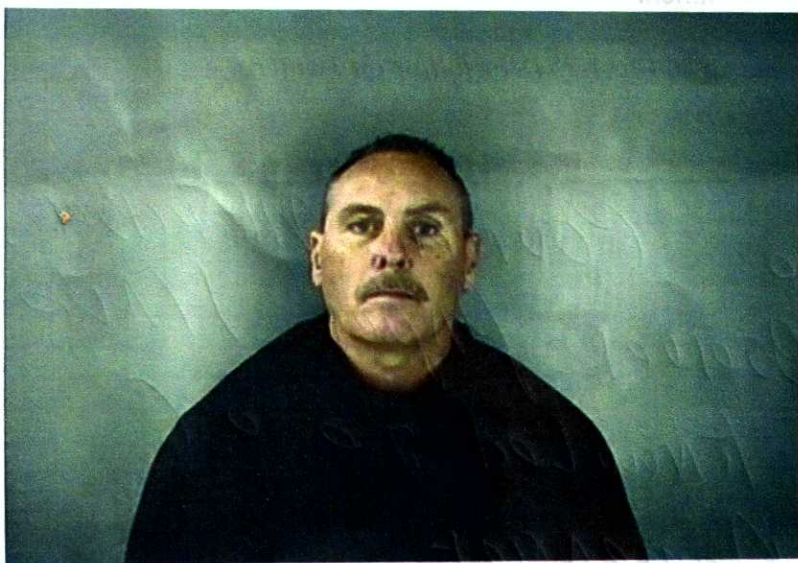

Authorities arrested the mayor of Ware Shoals Friday on domestic violence charges.

John Kay Hansen, 57, of 75 E. Cork St., Ware Shoals was arrested by a State Law Enforcement Division agent and charged with second and third-degree domestic violence, according to the Greenwood County Public Index. A judge set bond at \$2,500 cash for each charge, which Hansen posted.

SLED spokesman Thom Berry said Friday night no documents related to the case were available, including any incident reports and warrants. He said the arrest stems from a 2015 case.

"It's not something that happened recently," he said. "It involved information that came out of a family court case."

When reached for comment, Hansen said, "On the advice of counsel, no comment."

Hansen was first elected in 2012, and won a second term in November -- defeating Town Council member George Leagans with 371 votes to 302.

Messages were left for multiple members of the Ware Shoals Town Council, including Marshall Webster, Patricia Walters and Mayor Pro Tempore George Leagans.

Councilman Jack Sullivan said he had just read about the mayor's arrest at about 7 p.m. Friday, but declined to comment as he didn't know enough about the situation. Councilman John Brown likewise said he didn't know much about the situation.

Councilman Roy Landreth declined to comment.

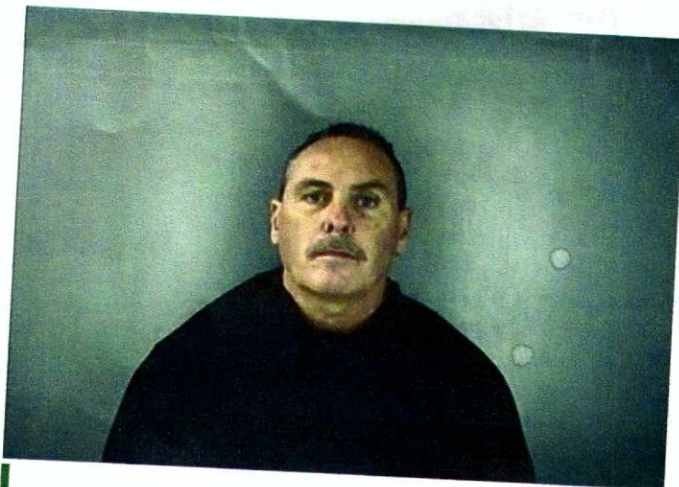

JOHN K. HANSEN

Warrants obtained from the State Law Enforcement Division on Tuesday detail the two incidents that led to domestic violence charges for Ware Shoals Mayor John Hansen.

On July 27, 2015, Hansen pushed a woman against a wall, pulled her hair, painted her face with house paint and spit in her face, according to one warrant dated Dec. 28.

Another warrant said on Sept. 19, Hansen pushed her against a wall and grabbed her by the arms -- visibly harming her and damaging a door in his 75 E. Cork St., Ware Shoals home. He also took her cellphone after she said she wanted to call 911, the warrant said.

John Kay Hansen, 57, was arrested Friday and charged with second- and third-degree domestic violence.

A judge set bond at \$2,500 cash for each charge, which Hansen posted.

"It's not something that happened recently," said SLED spokesman Thom Berry on Friday. "It involved information that came out of a family court case."

In a case filed with the Greenwood County Family Court, the woman was issued an order of protection by Judge John Rucker after she gave a statement about being assaulted.

"Sept. 19, 2016 is not the first time that John has put his hands on me," said the written statement, which was signed Oct. 3, 2016. "I have been terrified and afraid for my life to call the police because John is the mayor of Ware Shoals."

In the statement, she said she was afraid no one would believe her, and that she was afraid for her livelihood. The case contained photos of the bruises on her arms and back.

When reached for comment Friday, Hansen said, "On the advice of counsel, no comment."

The woman texted a comment Tuesday night, asking for people to refrain from commenting on social media.

"Even though we have the freedom to do so, remember that your remarks about what you think you know and what you may know are not helping anyone," she said. "You are not only hurting the two parties involved but you are hurting other family members as well. Please take that into consideration."

The woman gave a statement to Greenwood County's Victim Services on Sept. 19, detailing her assault. She said she had told Hansen she bought a mattress frame and other items for a relative as a housewarming gift when Hansen became mad, the statement said.

"He then grabbed me (and) threw me on the bed after he had slammed me against the wall," she wrote in the statement.

When she said she would call the police, Hansen took her phone from her and told her to walk to a pay phone, the statement said. As she got ready for work, he gave her back the phone and told her if she "called the police he would say I threw my

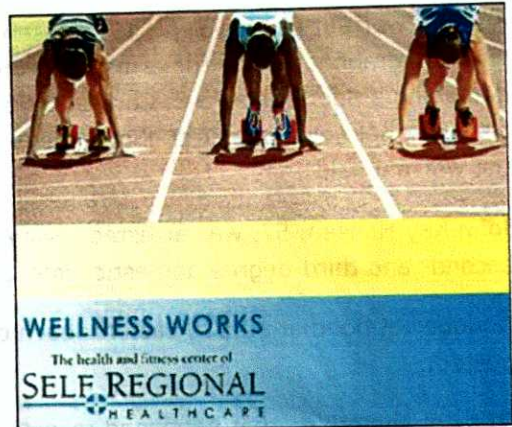

Hansen was first elected in 2012 and won a second term in November.

I have received a reply to my inquiry from the United States Postal Service. They advised us of the following:

Below are details on why the current location for the collection box at the Ware Shoals Post Office will be permanent.

A drive up box on the street was not allowed by the city because of safety/traffic flow issues. Maintenance will have a handrail installed for easier access up the one step to the door of the post office by the end of this week.

A collection box must be present in front of the post office for customer service, as with all offices. USPS doesn't place a new collection box unless mail volume warrants it, and Ware Shoals doesn't generate enough mail to qualify for a second box in another location. Minimum volume for a collection box to stay active is 200 per day, and the established location doesn't receive that amount.

Here are some facts that may be useful in understanding the legal obligations of the Postal Service related to accessibility at historic owned Post Offices such as Ware Shoals:

- *The United States Postal Service is subject to the Architectural Barriers Act of 1968 (ABA) rather than the more recent Americans with Disabilities Act of 1990 (ADA).*
- *USPS has a large inventory of owned Postal facilities that were constructed before passage of the ABA, and the Ware Shoals Main Office is one of these facilities.*
- *Owned facilities constructed before passage of the ABA are grandfathered, and current federal accessibility standards do not apply until the facility is altered.*
- *In the past, the Postal Service has conducted a variety of "voluntary" projects at older Postal facilities to improve their accessibility for customers and or employees when funding was available.*
- *Unfortunately, due to current financial and budgetary constraints, we are not able pursue such voluntary accessibility projects at this time. However, we will note this request, and may reconsider it in the future when the Postal Service does have the necessary financial resources.*
