United States Senator Lindsey Graham contacted our agency on your behalf regarding Medicaid eligibility and your healthcare needs.

Your Medicaid *Aged, Blind or Disabled* (ABD) application was denied on October 8, 2009. Marilyn Roberts, Medicaid Supervisor in our Lexington County Office, told us you plan to come by her office on Friday, October 30, to receive assistance in completing your application. If you will not be able to keep this appointment, please contact Ms. Roberts at (803) 785-2930.

Once the application process is complete, you will be notified in writing when a new eligibility determination is made. In the interim, we forwarded your request for a fair hearing to our Office of Appeals and Hearings should it be needed in the future.

An alternate health insurance option through Augco Benefits offers a variety of health insurance plans from top-rated insurance carriers. You may wish to look over the enclosed brochure and contact them at 1-866-273-5613 to see if they can be of assistance. Also enclosed is information on other programs and organizations that can assist residents in South Carolina with their healthcare services, prescriptions, inpatient hospitalization and daily living needs.
