



DEAR CUSTOMER:

This letter pertains to the Point System only, and is to inform you of your present standing under the Point System Law.

Our records now indicate that you have accumulated a total of 09 points for hazardous traffic law violations. Any applicable violations more than one year old have been decreased in point value. Certain traffic law violations, such as driving under the influence, require mandatory license suspension under the laws and are not under the Point System.

If you accumulate 12 points or more, you will receive a suspension letter. You will have 30 days from the date of that letter to enroll in a defensive driving course that may reduce the number of points on your record.
