Dear Lieut Gov Bryant,

Thank you for your willingness to visit our church this past Sunday and for the dynamic message that you preached.

Thank you also for allowing us to meet you after the service. You gave me your business card and I wanted to followup to tell you about the work that we are doing in Varnville and in Hampton County.

We are a 501C3 nonprofit organization and began by establishing vocational centers in India. We have helped to establish 9 vocational centers in 4 regions of India and are now working to do the same in the mission field in our own back yard - South Carolina and specifically Hampton County.

We purchased a vacant and abandoned building in Varnville that is 1/4 mile long - 126,000 sq ft. We are planning to establish certification training programs and craftsman and artisan makerspaces with the goal of becoming a business incubator for the disenfranchised in Hampton county and beyond.

We are in the process of restoring the building and have been seeking grant opportunities whenever possible.

We would love to have the opportunity to give you and your staff a tour of the 12 acres and building to see if there are any state resources available to help us with our goals.
