### Governor Nikki Haley News:

**Post and Courier:** Gov. Haley and leaders of House, Senate ask for new Supreme Court education hearing

South Carolina's top leaders pointed criticism this week of the state Supreme Court's recent landmark education ruling dampens expectations that the Legislature would use the case as a basis for drastic change to the state's K-12 education system, experts and officials said.

**Note:** Gov. Nikki Haley, along with House Speaker Jay Lucas, R-Hartsville, and Senate Pro-Tempore Hugh Leatherman, R-Florence, said in new court papers Tuesday that the justices' November decision in the Abbeville schools case was flawed.

**Note:** Haley said in her court filing that the Supreme Court had failed to consider the governor and Legislature's most recent action to direct more funding and resources to the state's rural, impoverished schools.
