Kevin,

I've attached a timeline that includes our services for your review. I've also requested updated fundraising/expense numbers and should have them before noon tomorrow. I've included some Long Term Recovery bullets that we plan to discuss in more detail with you when we meet with you at 3:30 tomorrow.

**Long Term Recovery:**

- Through continued follow up with nearly 1,500 clients ascertain gap needs and preliminary requirements to recovery. ARC will also provide information and referrals (I&R) to clients with specific needs. We can discuss in greater detail tomorrow.
- Access and training to partners on Client Assistance Network(CAN)-we'll discuss with you tomorrow what a big difference this will make.
- Working with Portlight Strategies on a grant to provide case management and recovery services to impacted South Carolina residents living with disabilities. The primary focus will be housing and accessing the totality of availability resources for this impacted community. We have worked with this organization on many large scale recovery programs and they are well suited to meet the needs.
- In coordination with the state VOAD (Volunteers Organizations Active in Disasters), provide technical support to Long Term Recovery Groups across the state which will result in the LTRGs better positioned to meet long term needs.
