EXTENSION OF BITUMINOUS RESURFACING CONTRACT  
TO INCLUDE ADDITIONAL RESURFACING WORK

It is recommended that the Commission approve the action of the Department in extending an existing bituminous retreatment contract to include additional resurfacing work as follows:

SPARTANBURG COUNTY:

Contract of Ashmore Brothers, Inc. - File No. 42.10951 and 42.409A - extended to include an additional section of Project C-409A (File No. 42.409A) consisting of the resurfacing of 1.0 mile on S-42-191 (Bryant Road) from I-85 to US 221; 1.40 miles on S-42-594 (Southgate Road) from SC 295 to S-590; 0.30 mile on S-42-654 (Syphrit Road) from US 29 to End of Maintenance; 0.60 mile on S-42-659 (Gosset Road) from S-31 to S-57 and 1.70 mile on S-42-943 (Halls Bridge Road) from SC 11 to Foster Road.

Estimated Cost of Extension

\$151,509.33

This extension was authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractor involved could not accept the additional work unless it were authorized without delay.

## **SURPLUS RIGHT OF WAY PROPERTY - LAND**

1. File 26.579 - US Highway 17 By-Pass - Horry County

During acquisition for construction of improvements to Highway 17 By-Pass in Horry County near Socastee the Department acquired right of Way by Easement from Daphin B. Turbeville and William Joseph Turbeville, Jr. and Dianne T. O'Quinn dated October 4, 1976, under File 26.579, Us Highway 17 By-Pass.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the right of way was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying 3 parcels totaling 0.68 acre to Palmetto Real Estate Holding, LLC was executed on March 24, 1995, for a consideration of \$131,107.67.

2. File 4.511 - Road S-71 - Anderson County

During acquisition of right of way for construction of improvements on Road S-71 in Anderson County, the Department acquired right of way from M. T. O'Neal by Easement dated February 17, 1961, under Road S-71, File 4.511.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the right of way could be relinquished. Therefore, a quitclaim deed conveying 0.11 acre of land to Mark A. Rhodes was executed on April 10, 1995, for a consideration of \$650.00.

3. File 36.423 - Road S-607 - Newberry County

During acquisition of right of way for construction of improvements on Road S-607 in Newberry County, the Department acquired right of way by Easement on April 12, 1972, from Saint Phillips Lutheran Church, under File 36.423.

At the request of the above party being the adjacent owner the SCDOT Commission determined this right of way to be no longer needed and should be removed from the Department's system. Therefore, a gratis quitclaim deed conveying 0.66 acre to Saint Phillips Lutheran Church was executed on April 21, 1995.

4. File 13.574 - SC Route 151 - Chesterfield County

During acquisition of right of way for construction of improvement on SC Route 151 in Chesterfield County, the Department acquired right of way by Title to Real Estate dated December 31, 1991, from Mae Nora Hough for drainage outfall ditches under File 13.574.

At the request of an adjoining owner, an investigation was made and it was determine that the subject outfall ditches were not needed or installed and the parcels could be relinquished. Therefore, a gratis quitclaim deed conveying approximately 6,480 square feet of land to Farmers Produce Market, Inc. was executed on April 24, 1995.

5. File 15.535 - SC Route 64 - Colleton County

During acquisition of right of way for construction of improvements on SC Route 64 in Walterboro, Colleton County, the Department acquired right of way from James C. Garrison, Jr. etal, by Title to Real Estate dated August 10, 1993, and filed in Colleton County RMC office under Deed Book 609, Pages 281-286.

At the request of an adjacent owner who provided right of way to the Department for construction of the relocation of Commerce Drive it was determined a swap of land was beneficial to the Department. Therefore, a gratis quitclaim deed to Mary Ann Burt and Francis McTeer Garrison was executed on April 24, 1995, for approximately 0.10 acre parcel of land.

6. File 26.437 - Road S-627 - Horry County

During acquisition of right of way for construction of improvement on Road S-627 in Horry County, the Department acquired right of way by dedication from Surfside Beach for Road S-627 under File 26.437.

At the request of an adjoining owner, an investigation was made and it was determined a portion of the right way was no longer needed. Therefore, a gratis quitclaim deed to Eleanor M. Gibson was executed on April 24, 1995, for a 0.03 acre parcel of land.

7. File 40.435A - Road S-244/80 - Richland County

During acquisition of right of way for construction of improvements to Road S-80 in Richland County the Department acquired right of way from Bouknight, etal, by Easement, filed in SCDOT deed vault in Columbia.

At the completion of new construction to relocate Road S-80 and at the request of the Bouknight family an investigation was made and it was determined the old S-80 roadbed was surplus property. Therefore, a gratis quitclaim deed to Marion S. Bouknight was executed on April 24, 1995, under File 40.435A for approximately 0.26 acre parcel of land.

8. File 40.673 - SC Route 215 - Richland County

During acquisition of right of way for construction of improvements to SC Route 215 in Richland County, the Department acquired right of way from Henry Lee Essick, etal, by Easement dated July 31, 1969, under SC Route 215, File 40.673.

Upon completion of construction to relocate SC Route 215 and at the request of an adjacent owner it was determined that the old SC Route 215 Roadbed was surplus property and should be granted back to the original adjacent donors. Therefore, a gratis quitclaim deed to Levi G. Shelley, Jr. was executed on April 24, 1995, for approximately 0.5 acre parcel of land.

This matter is reported to the Commission in accordance with the requirements of Code Section 57-5-340.

THE S. C. DEPARTMENT OF TRANSPORTATION COMMISSION  
MAY 18, 1995**

**WHEREAS,** the South Carolina Congressional Delegation supports the November 18, 1994 resolution from the South Carolina Department of Transportation Commission over the location of the proposed Route I-73, and

**WHEREAS,** the Delegation called the Commission's proposed route through South Carolina efficient in driving time and in construction costs, and

**WHEREAS**, South Carolina's senior Senator Storm Thurmond stood firm in the Senate Environment and Public Works Subcommittee and held fast to our proposed route and

**WHEREAS**, Senator Thurmond arranged for a meeting between North Carolina and South Carolina officials to work out misunderstandings, differences and conflicts over the proposed route, and

**WHEREAS**, the SCDOT Commission hereby unanimously supports Senator Thurmond's position in keeping the previously agreed upon entry point of I-73 into South Carolina, and

**WHEREAS**, the South Carolina Department of Transportation Commission desired to designate this facility so as to serve the needs of the traveling public, contemplated industry, the economic well being of the State, and the citizens of South Carolina, and

**WHEREAS**, the SCDOT Commission stands by the following proposed route - Beginning at and including the new Cooper River Bridge at Charleston, utilize U. S. Route 17 to Georgetown, from Georgetown US Route 701 to Conway, and from Conway follow the current location of US Route 501 including the Marion Bypass, and from Marion utilize S. C. Route 38 crossing I-95 in the vicinity of Oak Grove Community, continuing along Route 38 around or through the Towns of Brownsville and Blenheim to the Town of Bennettsville utilizing Route 9 and US Route 1, exiting South Carolina along US Route 1 near the Town of Wallace.

**BE IT RESOLVED**, the South Carolina Department of Transportation Commission hereby express its deep appreciation for the assistance and support given by Senator Thurmond during recent debates over the proposed route of I-73 through South Carolina and for protecting the State's economic, environmental and transportation well-being, and

**BE IT FURTHER RESOLVED**, that the South Carolina Department of Transportation Commission appreciates the continuous cooperation and support it receives from South Carolina's Congressional Delegation on all transportation related matters.

**SECTION 9:** On motion of Commissioner Whitehead, duly seconded the Commission unanimously passed a motion supporting each state's right to set the speed limit without penalty of losing federal funds.
