Good afternoon,

I am a guardian ad litem and Upstate Regional Coordinator for the Vulnerable Adult Guardian ad Litem Program, and yesterday I was notified of an adult male picked up by an Officer in Anderson County walking on a highway, disoriented, and without any identification. He was unable to state where he lived, and recalled a possible name, however, does not know how to spell his name. He appears to be in his 60s-70s and is in Emergency Protective Custody, placed at a memory care unit facility in Anderson. Fingerprints were taken, and missing person's reports were examined, but no matches have been made fitting his description. Due to this adult being vulnerable, not knowing any family or friends he may have, and no identifying information being found, I wanted to see if there was any further involvement that could be provided from Law Enforcement, such as a public service announcement.
