You don't need to appear in public to have your voice heard. You may submit comments or materials via email and those will be given to the Committee members.

All speaker's remarks and materials should be considered to be public upon receipt by the Committee.

This forum is to inform the Committee about tax policy issues and is not a forum for personal tax complaints or problems.
