When legislators return to work Tuesday, they will be greeted by a surplus of almost \$1.3 billion, a desire to put the long-standing issues of roads and rural schools behind them and optimism that they can accomplish great things in an election year.

**Note:** Gov. Nikki Haley last year proposed raising the gas tax by 10 cents per gallon but only if lawmakers changed the current system of selecting highway commissioners and approved an income tax cut.

Greenville County taxpayers appear to be out at least \$4.7 million in a failed plan to develop a downtown visitors center and a related education and adventure center in the Blue Ridge Mountains. Dream Big Greenville, a nonprofit organization formed to develop the projects, spent about \$8.7 million in hospitality tax revenue trying unsuccessfully to bring them about, according to county financial records.
