STANDARD INVESTIGATOR / CLAIMANT AGREEMENT

I. This agreement is entered into by and between Lauth Investigations International, Inc., a licensed and incorporated investigative firm, and its agent(s), hereinafter referred to as "Investigator", and **MARY MCASON**, hereinafter referred to as "Claimant" or "Heir", whose known residence is: **3 MILLPOND, COLUMBIA SC 29204-3401**

II. Investigator through its efforts has located Claimant, who may be entitled to the assets in the possession of a government office as described below ("Claim"):

ORIGINAL OWNER'S NAME: **RAYMOND CAMPBELL**

ORIGINAL OWNER'S ADDRESS AS REPORTED TO THE GOVERNMENT OFFICE:

OVERLOOK BRICKYARD PT RD APT A, BEAUFORT, SC 29902

TOTAL AMOUNT OF CLAIM(S): **\$8,906.00** NET AMOUNT AFTER 15.0% FEE: **\$7,570.10**

III. Claimant agrees that, in consideration of Investigator's efforts in locating and notifying Claimant of the existence of the Claim and assisting in the actual recovery of the Claim, Investigator is entitled to a fee equal to 15.0% of the net assets that Claimant recovers from Claim. This rate is permitted by applicable law. Claimant understands and agrees that the amount of the Claim stated above is only an estimated amount, and the actual Claim recovered may be more or less than that estimate. Claimant understands and agrees that Investigator's fee of 15.0% of the net assets actually recovered will reduce the Claimant's total received from the Claim.

IV. Claimant hereby appoints and authorizes Investigator and its agents as its exclusive agent to act on Claimant's behalf to obtain information and provide claim documents in order to obtain the Claim from the government agency. Claimant will not attempt to collect the Claim on his/her own behalf or appoint or engage any other person or company to attempt to collect the Claim; and no attempt to do any of the foregoing shall void Claimant's obligation to pay Investigator's fee if the Claim is recovered.

V. Claimant understands and agrees that the Claim recovery process and timeline is formulated solely by the government agency and is beyond the control of Investigator. Investigator does not guarantee recovery of all or any part of the Claim at any time or within any particular time period. No fee shall be owed if the Claim is never recovered; however, if the Claim (or any part of it) is recovered, Claimant must pay the fee upon receipt of the Claim check no matter when the Claim check is actually received.

VI. Claimant understands that any government check that is issued for the Claim will be made payable to the name of and mailed directly to Claimant. Claimant understands and agrees that it is obligated to mail or deliver the 15.0% fee to Investigator in the form of a Money Order, Cashier's Check or Certified Check made payable to Lauth Investigations International, Inc. within 10 calendar days after Claimant's receipt of unclaimed property from the applicable government office. Late payment fees may be assessed on accounts not paid by that date.

VII. This Agreement is governed by Indiana law without regard to conflicts of laws rules. Venue for all disputes shall be in courts located in Marion County, Indiana, and Claimant waives all objections to such venue. If legal action is necessary to enforce any of the terms of this Agreement, Investigator shall be entitled to reasonable attorney's fees in addition to any other relief to which it may be entitled.

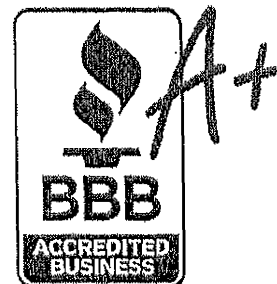
